ORDER:

The following Announcement has been made by the Hon'ble Chief Minister in the Collectors' Conference 2013:-

"Staff Nurse Quarters will be constructed for Primary Health Centres in Karur District where the number of deliveries are more than 10 per month".

2. The Director of Public Health and Preventive Medicine in the letter read above has sent proposal for construction of Staff Nurse Quarters in the following Upgraded Primary Health Centres (PHC) of Karur Health District Unit viz Mylampatti, (Kadavur Block) and Manmangalam, (Karur Block), where more than 10 deliveries are conducted per month, under National Rural Health Mission Programme Implementation Plan 2014-2015. The estimate cost for the construction of the Staff Nurse Quarters in the above said Primary Health Centres is Rs.36.00 lakhs ie Rs.18.00 lakhs per Primary Health Centre.

3. The Government have carefully examined the proposal of the Director of Public Health and Preventive Medicine and has decided to restrict it to Rs.15.50 lakhs per Staff Nurse Quarters per Primary Health Centre and to meet out the expenditure in this connection ie Rs.31.00 lakhs initially from the State funds and subsequently to include this item of expenditure in the National Rural Health Mission, Project Implementation Plan 2014-2015. Accordingly, sanction is accorded for a sum of Rs.31.00 lakhs (Rupees Thirty One Lakhs only) for the construction of Staff Nurse Quarters (@ Rs. 15.50 lakhs per Staff Nurse Quarters per Primary Health Centre) in the Primary Health Centres at Karur Health District Unit viz Mylampatti, (Kadavur Block) and Manmangalam, (Karur Block).

4. The expenditure sanctioned at para 3 above shall be debited to the following head of account:-

4210 Capital Outlay on Medical and Public Health – 02. Rural Health Services – 103. Primary Health Centres – Schemes in the Twelfth Five Year Plan – II. State Plan – JA. Buildings – 16. Major Works (DPC 4210 02 103 JA 1606)

5. The expenditure sanctioned in para 3 above constitutes an item of "New Service". The approval of the Legislature will be obtained in due course pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from Contingency Fund, orders regarding which will be issued by Finance (BG.I) Department separately. The Chief Engineer (Buildings) is requested to send necessary proposal to Government in Finance (BG.I) Department in the prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2014-15 to Finance (BG.I) Department, at an appropriate time without fail.

6. This order issues with the concurrence of the Finance Department vide its U.O.No. 110/ADS (Dr.PU)/Health-I/2014, dated 27.02.2014 and ASL No. 64 (Sixty Four).
