National Health Mission – State Health Society – Tamil Nadu –Sanction of Rs.12.00 crore for Civil works in respect of 25 Primary Health Centres - Orders - Issued.

ORDER:

In Government order second read above, orders were issued for establishment of 25 new Primary Health Centres at a total cost of Rs.1500.00 lakh and a sum of Rs.300.00 lakh being 20% of the total requirement for Civil Works of Rs.1500 lakh (Rs.60 lakh x 25 PHCs) has been sanctioned for execution of civil works through Public Works Department.

- 2. In the letter third read above, the Mission Director, State Health Society has stated that in Supplementary Record of Proceedings 2016-17, the Government of India has approved the balance of fund Rs.1200.00 lakh being 80% of the total requirement for Civil Works of Rs.1500 lakh.
- 3. The Mission Director has also stated that as per the Government order first read above, the amount of Rs.1200.00 lakh approved by the Government of India has been remitted into Government of Tamil Nadu account vide challan No.217, dated 20.2.2018.
- 4. The Mission Director, National Health Mission has therefore requested necessary Government orders in this regard.
- 5. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-

- i. Sanction is accorded for a sum of Rs.12,00,00,000/-(Rupees Twelve crore only) for execution of civil works in 25 Primary Health Centres established vide Government Order second read above, through Public Works Department.
- ii. The Engineer-in-Chief (Building) and Chief Engineer (Buildings), Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned division for the drawl of funds.
- 6. The expenditure sanctioned in para 5(i) above shall be debited into the following Head of Account:-

"4211-00 Capital outlay on Family Welfare – 103 Maternity and Child Health – State's Expenditure – AA Civil Works under National Health Mission Scheme- 16 Major works"

(DPC No. 4211 00 103 AA 1606)

- 7. Necessary funds are provided in BE 18-19. The Chief Engineer (Buildings)/Engineer in Chief (Building) Public Works Department is authorized to draw and disburse the amount sanctioned in para 5(i) above.
