The Mission Director, National Health Mission in his letter read above, has stated that the Government of India have transferred and credited into State Government Account its share towards Release of Grants-in-Aid for Asha Benefit Package and Asha Facilitator covered under Reproductive Child Health Flexible Pool Programme and Organizing Health Mela in all Lok Sabha covered under National Rural Health Mission Programme during 2018-19 as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.3,26,42,105/- (Rupees Three Crore Twenty Six Lakh Forty Two Thousand One Hundred and Five only) works out of Rs.2,17,61,403/- (Rupees Two Crore Seventeen Lakh Sixty One Thousand Four Hundred and Three only).

2. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.5,44,03,508/- (Rupees Five Crore Forty Four Lakh Three Thousand Five Hundred and Eight only) being the State and Central Share contribution of Grants-in-Aid to the Asha Benefit Package and Asha Facilitator covered under Reproductive Child Health Flexible Pool Programme and Organizing Health Mela in all Lok Sabha covered under

National Rural Health Mission Programme during 2018-19 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.

The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.5,44,03,508/- (Rupees Five Crôre Forty Four Lakh Three Thousand Five Hundred and Eight Only) being the State and Central Share contribution of Grants-in-Aid to the Asha Benefit Package and Asha Facilitator covered under RCH Flexible Pool Programme and Organizing Health Mela in all Lok Sabha covered under NRHM Programme for the year 2018 – 2019.
