#### ORDER:-

The Director of Medical Education in the letters third read above, has sent the proposal for construction of additional Examination Hall Building for 250 students in first floor over the existing Examination Hall in Government Theni Medical College, Theni.

- 2. In the Government Order first read above, orders have been issued for starting of new Government Theni Medical College, Theni. In the Government Order second read above, administrative and financia! sanction was accorded for construction of new Medical College and Hostel Buildings for Government Theni Medical College, Theni at a cost of Rs.46.93 crore (i.e) Rs.23.03 crore for College buildings and Rs.23.90 crore for Hostel buildings. Accordingly, Examination Hall has been constructed for 482.36 sq.m.in Government Theni Medical College, Theni. However, as per Medical Council of India norms, building with 800 sq.m, is mandatory. The Director of Medical Education has stated that the plan for the proposed additional Examination Hall Building for 250 students in first floor over the existing Examination Hall has been prepared with a total plinth area of 482.36 sq.m. The existing building is designed for Ground + 1 floor.
- 3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Madurai Region based on the schedule of rates for the year 2015-2016 and has requested the Government to accord administrative and financial sanction for a sum of Rs.74,00,000/- for construction of additional Examination Hall Building for 250 students in first floor over the existing Examination Hall in Government Theni Medical College, Theni.

- 4. The Government, after careful examination, accept the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.74,00,000/- (Rupees seventy four lakh only) for the construction of additional Examination Hall Building for 250 students in first floor over the existing Examination Hall in Government Theni Medical College, Theni as per the schedule of rates for the vear 2015-2016.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

"4210 - Capital Outlay on Medical and Public Health - 01 Urban Health Services - 110 - Hospitals and Dispensaries (including Pharmacy) - Schemes in the Twelfth Five Year Plan-II - State Plan - JA - Buildings - 16 Major Works.

- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of the legislature will be obtained in due course. Pending approval of legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.44055/Health-II/2015, dated.11.08.2015 and ASL No.716 (Seven hundred and sixteen).
