ORDER:

In Government Order sixth read above, permission was granted to the Chairman, Kovai Medical Centre Research and Educational Trust, Coimbatore to start B.Pharmacy Degree course with an annual intake of 50 students from the academic year 1993-1994.

2. The Managing Trustee, KMCH College of Pharmacy, Coimbatore has requested the Government to grant permission to enhance the B.Pharmacy course from 60 to 100 seats from the academic year 2019-2020 at KMCH College of Pharmacy, Coimbatore.

3. In its Government letter fifth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Pharmacy has fulfilled the conditions prescribed by the Government in the Government Orders first, second and fourth read above and the Pharmacy Council of India, New Delhi.

4. The Director of Medical Education in the proposal sent in its letter sixth read above has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Pharmacy Council of India. Hence, the Director of Medical Education has recommended that permission may be granted to the Managing Trustee, KMCH College of Pharmacy, Coimbatore to enhance the B.Pharmacy course from 60 to 100 seats from the academic year 2019-2020 at KMCH College of Pharmacy, Coimbatore.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Managing Trustee, KMCH College of Pharmacy, Coimbatore to enhance the B.Pharmacy course from 60 to 100 seats from the academic year 2019-2020 at KMCH College of Pharmacy in S.F. No.940/1A, 1B at Kalapatti Village and Panchayat, Coimbatore District. Accordingly, the Government do and hereby direct that the Managing Trustee, KMCH College of Pharmacy, Coimbatore is permitted to enhance the B.Pharmacy course from 60 (sixty) to 100 (one hundred) seats from the academic year 2019-2020 at KMCH College of Pharmacy in S.F. No.940/1A, 1B at Kalapatti Village and Panchayat, Coimbatore District, subject to the following conditions:-

- a) The Trust should obtain the building completion certificate from the competent authority before admitting the students.
- b) Admission of students shall be made as per the rules fixed by the Government from time to time;
- c) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said college;
- d) The Trust should obtain recognition / affiliation from the Pharmacy Council of India and the Tamil Nadu Dr. M.G.R. Medical University respectively before admitting the students;
- e) The Government have the right to utilize the Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding up of course without valid reasons, etc;

- f) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after obtaining getting orders of Government on re-inspection of the centres.

6. The Director of Medical Education is directed to take necessary further action accordingly.
