ORDER:

In Government Order sixth read above, permission was granted to the Chairman, Kovai Medical Centre and Hospital Limited, Avinashi Road, Coimbatore to start B.Sc Nursing Degree course with an annual intake of 50 students from the academic year 1992-1993.

- 2. In Government Order seventh read above, permission was granted to the Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore District for increase the annual intake of seats from 50 to 100 in B.Sc Nursing course at K.M.C.H College of Nursing, Coimbatore from the academic year 2007-2008.
- 3. The Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore has requested the Government to grant permission to shift the college to the new premises from KMCH campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District in KMCH College of Nursing, Coimbatore.
- 4. In its Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth read above and the Indian Nursing Council, New Delhi.
- 5. In his letter ninth read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore to shift the college to the new premises from KMCH campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District in KMCH College of Nursing, Coimbatore.
- 6. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore to shift the college to the new premises from KMCH campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District in KMCH College of Nursing, Coimbatore. Accordingly, the Government do and hereby direct that the Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore is permitted to shifting the college to the new premises from KMCH campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District in KMCH College of Nursing, Coimbatore, subject to the following conditions:
 - a) Admission of students shall be made as per the rules fixed by the Government from time to time.
 - b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said college.

- c) The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi respectively before admitting the students.
- d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- e) The Institution so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- f) The Trust should not run any other Nursing institution within 10 kms radius.
- 7. The Director of Medical Education is directed to take necessary further action accordingly.
