ORDER:

The Director of Medical Education, in the letter read above, has sent the proposal for the construction of Residential quarters (for teaching and non teaching staff) at Government Mohan Kumaramangalam Medical College, Salem.

- 2. In G.O.(Ms) No.307, Health and Family Welfare (J1) Department, dated 23.12.2013, Government have sanctioned a sum of Rs.241.00 lakh for the construction of additional Library building at Government Mohan Kumaramangalam Medical College, Salem.
- 3. The Director of Medical Education has stated that during the last Medical Council of India inspection conducted at the College for the increase of intake of MBBS students from 75 to 100, it has been pointed out that there is no residential quarters for staffs as a major deficiency. As per the Medical Council of India norms, since residential quarters is absolutely essential, the Dean has sent proposal along with rough cost estimate for the construction of Residential Quarters (for teaching and non teaching staff) at Government Mohan Kumaramangalam Medical College, Salem.
- 4. The Director of Medical Education has requested the Government to accord administrative and financial sanction for a sum of Rs 902.00 lakh in the schedule of rates for the year 2014-2015 for the construction of Residential quarters (for teaching and non teaching staff) at Government Mohan Kumaramangalam Medical College, Salem. She has countersigned and forwarded the rough cost estimate prepared by the

Engineer-in-Chief and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai.

- 5. The Government have examined the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs 902.00 lakh (Rupees nine crore and two lakh only) in the schedule of rates for the year 2014-2015 for the construction of Residential quarters (for teaching and non teaching staff) at Government Mohan Kumaramangalam Medical College, Salem
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health - 01 Urban Health Services - 110 - Hospitals and Dispensaries (Including Pharmacy) - Schemes in the Twelfth Five Year Plan - II State Plan - JA Buildings - 16 Major Works" (DPC 4210-01-110-JA -1602)

- 7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.
- 8. This order issues with the concurrence of Finance Department vide its U.O.No.44050/Health-II/2015, dated:11.08.2015 ASL No.717 (Seven hundred and seventeen).
