### ORDER:-

The Director of Medical Education in his letter read above has stated that the Additional Director of General Police/ Director, Tamil Nadu Fire and Rescue Services Department, Chennai Northern region (MSB Inspection team) had inspected the building of Rajiv Gandhi Government General Hospital, Chennai on 15.02.2017 and pointed out the following defects:-

1. Wet riser systems should be kept in working condition
2. Fire service inlet fitted with NRV should be kept in working condition
3. Yard hydrants should be in working condition
4. Manual Fire alarm call points should be kept in working condition.
5. Fire pumps are should be kept in working condition
6. Automatic sprinkler system should be provided in the basement area
7. Automatic smoke Detector with fire alarm should be kept in working condition.
8. Diesel pumps of capacity 2850 LPM should be provided for each towers.

To rectify the above said defects the Dean, Madras Medical College has requested the Public Works Department authorities to prepare rough cost estimate to provide Fire Protective Devices in Tower Block I&II in Rajiv Gandhi Government General Hospital, Chennai. Accordingly, the Chief Engineer (Buildings), Chennai Region has prepared the rough cost estimate to provide the following Fire Protective Devices in Tower Block I&II in Rajiv Gandhi Government General Hospital, Chennai, which works out to Rs.29.81 lakh, duly countersigned by the Director of Medical Education:-

2. The Director of Medical Education has therefore requested the Government to accord administrative and financial sanction for a sum of Rs.29.81 lakh to provide the above said Fire Protective Devices in Tower Block I&II in the Rajiv Gandhi Government General Hospital, Chennai.

3. The Government after careful examination of the proposal of Director of Medical Education accord administrative and financial sanction for a sum of Rs.29,81,000/- lakh (Rupees twenty nine lakh and eighty one thousand only) for providing Fire Protective Devices in Tower Block I&II in the Rajiv Gandhi Government General Hospital, Chennai.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of account:-

"4210. Capital outlay on Medical and Public Health - 01. Urban Health Services - 110. Hospital and Dispensaries - (Including Pharmacy) - State's Expenditure - JA - Buildings - 16 Major Works (DPC 4210-01-110-JA-1602)"

5. The expenditure sanction para 3 above shall constitute "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by draw of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department, Chennai is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings), Public Works Department, Chennai is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018-2019 to Finance (B.G.I) Department at the appropriate time without fail.

6. This order issues with the concurrence of Finance Department vide its U.O.No.28436/Health-II/2018, dated: 18.06.2018. ASL No.432 (Four hundred and Thirty two).
