ORDER:

The Registrar, Sri Balaji Vidyapeeth Deemed University, Pondhicherry has requested the Government to grant permission to start four years B.Sc (Nursing) course in the name and style as "Shri Sathya Sai College of Nursing, Thiruporur, Kancheepuram District" with an annual intake of 100 students from the academic year 2019-2020.

2. In its Government letter sixth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth read above and the Indian Nursing Council, New Delhi.

- 3. In his letter seventh read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Registrar, Sri Balaji Vidyapeeth Deemed University, Pondhicherry to start four years B.Sc (Nursing) course in the name and style as "Shri Sathya Sai College of Nursing, Thiruporur, Kancheepuram District" with an annual intake of 100 students from the academic year 2019-2020.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Registrar, Sri Balaji Vidyapeeth Deemed University, Pondhicherry to start four years B.Sc (Nursing) course with an annual intake of 100 (hundred) students in the name and style as Shri Sathya Sai College of Nursing in the Shri Sathya Sai Medical College and Research Institute Campus, Thiruporur, Kancheepuram District from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Registrar, Sri Balaji Vidyapeeth Deemed University, Pondhicherry is permitted to start four years B.Sc (Nursing) course with an annual intake of 100 (hundred) students in the name and style as Shri Sathya Sai College of Nursing in the Shri Sathya Sai Medical College and Research Institute Campus, Thiruporur, Kancheepuram District from the academic year 2019-2020, subject to the following conditions:
 - i. The Trust should construct a separate new building in the name of Shri Sathya Sai College of Nursing in the Medical College Campus before completion of 1st year B.Sc (N) course as per the undertaking given by them and also should obtain No Objection Certificate from the Government.
 - ii. The Trust should obtain building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed nursing college building.
 - iii. The Trust should obtain the building completion certificate from the competent authority ie. PWD for the proposed nursing college building.
 - iv. Admission of students shall be made as per the rules fixed by the Government from time to time.
 - v. Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said college.
 - vi. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi respectively before admitting the students.

- vii. The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- viii. The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- ix. The Trust should provide computer room with 10 computers in the laboratory.
- x. The Trust should fulfill the teaching staffs for subsequent years after completion of 1st year B.Sc (N) course.
- xi. The Trust should fulfill the journals of library books.
- xii. The Trust should provide Hostel facilities for girls.
- 5. The Director of Medical Education is directed to take necessary further action accordingly.
