#### **ORDER:**

The Director of Medical Education in the letter read above, has sent the proposal for the construction of new Mortuary Block in Government Mohan Kumaramangalam Medical College Hospital, Salem.

2. The Director of Medical Education has stated that one Mortuary Block is functioning at the North West side corner of the Government Mohan Kumaramangalam Medical College Hospital campus. This block does not fulfil the Medical Council of India requirements. As per Medical Council of India norms, in the Department of Pathology, the following requirement is needed:-

"Autopsy Block - There shall be an Autopsy room (approximately 400 sq mt. area) with facilities for cold storage, for cadavers, ante-rooms, washing facilities, with an accommodation capacity of 20-25 students, waiting hall and office. The location of mortuary and autopsy block should be either in the hospital or adjacent to the hospital in a separate structure and may be shared with the Department of Forensic Medicine."

She has further stated that site is available in the above Medical College Hospital Campus and the plan is adopted as per the norms adopted in Dharmapuri Medical College Hospital.

3. The Director of Medical Education has requested the Government to accord administrative and financial sanction for a sum of Rs.1,23,20,000/- in the schedule of rates for the year 2015-2016 for the construction of new Mortuary Block in Government Mohan Kumaramangalam Medical College Hospital, Salem. She has countersigned and forwarded the rough cost estimate prepared by the Engineer-in-Chief and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai.

- 4. The Government have examined the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.1,23,20,000/- (Rupees one crore twenty three lakh and twenty thousand only) in the schedule of rates for the year 2015-2016 for the construction of new Mortuary Block in Government Mohan Kumaramangalam Medical College Hospital, Salem.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-
  - "4210 Capital Outlay on Medical and Public Health 01 Urban Health Services 110 Hospitals and Dispensaries (Including Pharmacy) Schemes in the Twelfth Five Year Plan II State Plan JA Buildings 16 Major Works" (DPC 4210-01-110-JA -1602)
- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next supplementary estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is requested to send necessary explanatory notes to include the above expenditure in the supplementary estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.43786/Health-II/2015, dated:11.08.2015 and ASL No. 715 (Seven hundred and fifteen).
