The Government of India have sanctioned its share towards release of Grants-in-Aid for National Vector Borne Disease Control Programme during 2017-18 as detailed below:-

2. The corresponding 40% of the State Share against the 60% of the Government of India sanction of Rs. 3,45,00,000/- (Rupees three crore and forty five lakh only) works out Rs.2,30,00,000/- (Rupees two crore and thirty lakh only).

3. The Mission Director, State Health Society has requested the Government to issue orders for the release of a sum of Rs.5,75,00,000/- (Rupees five crore and seventy five lakh only) being Central and State share contribution of Grants-in-aid to the State Health Society for National Vector Borne Disease Control Programmes during 2017-18 as mentioned above and to authorize him, to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.

4. Considering, the Government of India has released only the Scheduled Caste Sub-Plan (SCSP) and Tribes Sub-Plan (TSP) component, the Government after careful consideration sanction a sum of Rs.121,66,667/- (Rupees one crore twenty one lakh sixty six thousand six hundred and sixty seven only) towards the release of Central and State share contribution of Grants-in-Aid to the State Health Society under Nation Rural Health Mission for the (SCSP-TSP) component of National Vector Borne Disease Control Programme during the year 2017-2018.
