ORDER:

In the Government order read above, the Government accorded approval for extension of the existing Health Management Information System Phase III software development and Phase I Software Application Maintenance Cost contract signed with M/s Tata Consultancy Services, for the further period from 07.07.2014 to 30.09.2014, in connection with the implementation of Health Management Information System Phase III activities. The Tamil Nadu Health Systems Project has now sent the proposal which was approved by the State Empowered Committee of the Tamil Nadu Health Systems Project in its meeting on 13.07.2015. As per the proposal to the State Empowered Committee, the contract (as approved by the World Bank with the same firm) was approved covering the activities from 01.10.2014 till 15.09.2015 and signed on March 7, 2015.

2. The Project Director, Tamil Nadu Health Systems Project has stated that the existing application developer need to exist in parallel during the initial phase of the consultant firm for Annual Technical Support, for the transition of the Health Management Information System application from the existing application developer to the consultant firm. The contract with the existing application developer was valid till

15th September 2015. It is hence proposed that the contract with the existing application developer may be extended for a period of six months from 16th September 2015 to continue the application / server support till the consultant firm takes over and to support the transition of the Health Management Information System application to the consultant firm. Accordingly, the Principal Secretary / Project Director, Tamil Nadu Health Systems Project had placed the necessary proposals before the State Empowered Committee in the meeting held on 13.07.2015 which had approved it and the Project Director has requested Government orders to Sanction a sum of Rs.3,13,50,000/- (inclusive of service tax @ 14%) for entering into a contract with the existing Health Management Information System application consultant firm M/s.Tata Consultancy Services for the period upto 15.09.2015.

- 3. The Project Director, Tamil Nadu Health Systems Project has further stated that to exemption for the existing application developer from Server support from the State Funds for 6 months has indicated that this application maintenance component can be effectively done by the original developer and this is eligible under clause 16 (b) of the Tamil Nadu Transparency in Tender Act and to sanction Rs. 57.00 lakh from the State funds—to extend the contract with the existing application developer for a period of 6 months—beyond the project period from 16th September 2015 to continue the application/server support—through Single Source Selection methodology to cover the training of end users and continued application maintenance and server management support.
- 4. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project, accord sanction for a sum of Rs.57.00 lakh (Rupees Fifty seven lakh only) inclusive of Service Tax (14%) for extension of the contract with the existing application developer for a further period of 6 months from 16.09.2015 to continue the application / server support till the new consultant takes over, from the State Government funds under clause 16 (b) of Tamil Nadu Transparency in Tender Act.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account

2210 – Medical and Public Health -01 Urban Health Services – Allopathy -800 other expenditure – Schemes in the Twelfth Five Year Plan – Il State Plan PA – Tamil Nadu Health Systems Society 09 – Grants in aid 03 – Grants for specific schemes. (DPC 2210 -01 -800 –PA -0939)

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Project Director, Tamil Nadu Health Systems Project is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended

to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Project Director, Tamil Nadu Health Systems Project is requested to send necessary explanatory notes to include the above expenditure in the Revised Budget Estimate / Supplementary Estimates for the year 2016-17 to Finance Department at the appropriate time without fail.

7. This order issues with the concurrence of the State Empowered Committee constituted in G.O. (Ms).No.28, Health and Family Welfare Department, dated 28.02.2005 and Finance Department vide its .U.O. No.81/ADS(Dr.PU)/Health-II/2016, dated: 04.03.2016 and Additional Sanction Ledger No. 2578 (Two Thousand Five Hundred and Seventy Eight).
