ORDER:

The Mission Director, State Health Society in the letter read above has stated that the Central funds under the Centrally Sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State plan and requested to provide for Central Share of National Health Mission in the State Budget.

2. The Government of India in their letter read above have transferred and credited a sum of Rs.55,95,00,000/- (Rupees Fifty five Crore and ninety five lakh only) into State Government account as its 75% share of the grants for creation of Capital assets under National Urban Health Mission Flexible Pool for the year 2015-16 as mentioned below:-

The Government of India has requested to ensure 25% State contribution based on the release of funds by Government of India.

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State Share against the 75% of the Government of India release of Rs.55,95,00,000/- (Rupees Fifty five crore and ninety five lakh only) works out to Rs.18,65,00,000/- (Rupees Eighteen crore and sixty five lakh only). Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of Central Share and State Share will have to be drawn from State Budget. He has requested the Government to issue orders to release a sum of Rs.74,60,00,000/- (Rupees Seventy four crore and sixty lakh only) towards release of Central and State contribution of Grants in aid to the State Health Society under National Urban Health Mission Flexible Pool for the year 2015-16 and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.74,60,00,000/- (Rupees Seventy four core and sixty lakh only) under National Health Mission through Treasury mode.

3. The Government after careful consideration have decided to accept the above proposals of the Mission Director, State Health Society and accordingly sanction a sum of Rs.74,60,00,000/- (Rupees Seventy four crore and sixty lakh only) i.e.,Rs.55,95,00,000/- (Rupees Fifty five crore and ninety five lakh only) being 75% Central Share and Rs. 18,65,00,000/- (Rupees Eighteen crore and sixty five lakh only). being 25% of the State share as matching grant to the State Health Society, Tamil Nadu as grants for creation of capital assets and grants in aid under National Urban Health Mission Flexible Pool for the year 2015-16.
