## **ORDER:**

The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have sanctioned Grants-in-Aid for National Health Mission in ROP 2019-20. The ROP for 2019-20 had been placed and approved in 37<sup>th</sup> EC. Now, the Government of India have released Grants-in-Aid for various programmes under Flexible Pool of Non-Communicable Diseases for the activities covered under National Rural Health Mission for the year- 2019-20 and has been credited into State Government Account as detailed below:-
