Order:

The Mission Director, State Health Society in his letter 2nd read above has stated that it has been proposed to strengthen the infrastructures of Medical College Hospitals so as to enable them to provide Quality, Curative and Preventive Health Care Services for the total populations of the State. In the year 2013-14, various civil works for strengthening infrastructure of tertiary care institutions were proposed in the 2nd supplementary Programme Implementation Plan (PIP) 2013-14. The National Programme Coordination Committee (NPCC) of Government of India approved the proposals as detailed below:

2) He has stated further that, the proposal has been approved in the 26th Executive Committee (EC) Meeting held on 04.02.2014 against Agenda No.17. As per the guidelines issued in the G.O.(Ms) No.116 Health and Family Welfare Department, dated 25.03.2011, the fund of Rs.820 lakh has been remitted into

Government of Tamil Nadu amount vide chalan No. 2810, dated: 26.06.2014 of State Bank of India, Treasury Branch, Thousand Lights, Chennai-6 under the receipt head. Necessary proposals have been included in the RE 2014-15 for the allotment of the above funds of Rs.820 lakh. The Mission Director, State Health Society has requested the Government to issue necessary Government Orders for the execution of civil works.

3) The Government after careful examination has decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction a sum of Rs.8,20,00,000/- (Rupees Eight Crore and Twenty Lakh only) to the Chief Engineer (Buildings), Public Works Department(Public Works Department), Chennai for the execution of various works in the Government Medical College Hospitals mentioned in para 1 above.

4) The expenditure sanctioned in para 3 above shall be debited to the following head of account:

4211 00 Capital Outlay on Family Welfare – 103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan III Centrally sponsored SA – National Component – Reproductive and Child Health Project – 16 Major works (DPC 4211-00-103-SA-1608)

5. Necessary funds will be provided in FMA 2014-2015. Pending provision of such funds in FMA 2014-2015, the Chief Engineer (Building), Public Works Department, Chennai is authorized to draw and disburse the amount sanctioned in Para 4 above. He is requested to include the above expenditure while sending proposals for FMA 2014-2015 to Government in Finance (BG –I (Health-I) Department at an appropriate time. However the above expenditure shall be brought to the notice of the Legislative Assembly by a Specific inclusion in the Supplementary Estimates. He is also requested to send necessary draft explanatory notes to the Government in Finance (BG-I (Health-I) Department for inclusion of the above expenditure by a Specific inclusion in the Supplementary Estimates at an appropriate time without fail.
