ORDER:

In the Government Order first read above, the Government have accorded sanction for the establishment of new Government Medical College and Hospital at Thiruvannamalai. In the Government order second read above, the Government have issued orders transferring the existing Government Headquarters Hospital, Thiruvannamalai functioning under the control of Director of Medical and Rural Health Services to the administrative control of Director of Medical Education. Accordingly, all the infrastructure facilities like building, equipment, vehicles and medical, para medical and administrative staff etc., have been taken over by the Dean, Government Thiruvannamalai Medical College, Thiruvannamalai. In the Government Orders first, third and fifth read above, 327 posts of various categories were sanctioned to Government Thiruvannamalai Medical College and Hospital at Thiruvannamalai.

2. The Medical Council of India, New Delhi in the letter fourth read above, have issued "Letter of Permission" to start Government Thiruvannamalai Medical College, Thiruvannamalai under the control of the Director of Medical Education.

- 3. The Director of Medical Education has stated that the existing posts of Chief Civil Surgeon attached to Government Head Quarters Hospital, Thiruvannamalai has to be redesignated as Associate Professor / Professor to suit the norms of Medical Council of India.
- 4. The Director of Medical Education has requested the Government to redesignate nineteen posts of various categories attached to Government Thiruvannamalai Medical College, Thiruvannamalai to suit the Medical Council of India norms. She has also requested to release the existing non-qualified Medical Officers to the Directorate of Medical and Rural Health Services and Directorate of Public Health and Preventive Medicine as they do not suit any norms of Medical Council of India.
- 5. The Government, after careful examination, direct that the existing nineteen posts of various specialities in Government Thiruvannamalai Medical College and Hospital, Thiruvannamalai be redesignated as detailed in the Annexure to this order. The Director of Medical Education is permitted to release the existing non-qualified Medical Officers to the Directorate of Medical and Rural Health Services and Directorate of Public Health and Preventive Medicine as they do not suit any norms of Medical Council of India.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.43491/Health-II/2015, Dated.05.08.2015.
