ORDER:

The Government of Tamil Nadu with an aim to promote the people's welfare is being implementing the free medical services through Chief Minister's Comprehensive Health Insurance Scheme.

2. The World Health Organization has declared the recent COVID-19 epidemic as Public Health Emergency of International Concern (PHEIC) and has also characterized it as a controllable pandemic. The Government of Tamil Nadu declared the Corona Virus Disease (COVID – 19) as a notified disease throughout the State of Tamil Nadu under the Tamil Nadu Public Health Act and also declared the threat of outbreak of Corona Virus Disease (COVID – 19) a notified disease throughout the State of Tamil Nadu under the Tamil Nadu Public Health Act and Government have also issued notification prescribing regulations to prevent the outbreak of Corona Virus Disease (COVID-19) under the Epidemic Diseases Act 1897 (Central Act No.3 of 1897). The Revenue and Disaster Management Department has notified the COVID -19 as infection Prevention and Control under the Disaster Management Act – 2005.

- 3. In the letter sixth read above, the Project Director, Tamil Nadu Health Systems Project has mentioned that a High level Core Committee meeting was held on 14.5.2021 to discuss about the ceiling rates for the Covid 19 treatment provided by the empanelled hospitals for the beneficiaries under Chief Minister's Comprehensive Health Insurance Scheme and after the consultation with the Head of the Departments of Health and Family Welfare Department, he has submitted a proposal to the Government for providing Covid 19 treatment at free of cost to the poor people under the Chief Minister's Comprehensive Health Insurance Scheme.
- 4. After careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project, the Government of Tamil Nadu have ordered as follows:
 - a) All private hospitals permitted by the Director of Medical and Rural Health Services providing Covid 19 treatment are temporarily accredited under Chief Minister's Comprehensive Health Insurance Scheme.
 - b) As per the announcement made by the Hon'ble Chief Minister, the expenses incurred in the private hospitals for all the critical and non critical Covid 19 patients shall be borne under Chief Minister's Comprehensive Health Insurance Scheme.
 - c)As per the Government Order fifth read above, the committee's recommendations that no need a referral form of the Government Doctor to avail Covid 19 treatment at private hospitals under Chief Minister's Comprehensive Health Insurance Scheme is accepted.
 - d) The rates already fixed in the Government Order first read above for the Covid 19 treatment for the empanelled hospitals under the Chief Minister's Comprehensive Health Insurance Scheme is fixed as follows to safeguard the welfare of the people during this pandemic period and to provide treatment at free of cost.

Additional Charges will be paid under the scheme for D-Dimer, IL6, LDH tests,.

Additional Charges will be paid under the scheme for the medicines such as Remdesivir, Tocilzumab, Itolizumab, etc.

Guidelines for payment and processing will be provided separately.

E) In this Corona pandemic situation, for getting timely treatment without any delay, with the intention to save the precious life of the people, the charges for Covid-19 treatment in private hospitals have been fixed as Rs. 5000/- to Rs.7500/- for non-critical treatment and Rs 15,000/- for critical treatment in the above said Government Order. Now, this charge is fixed in accordance with the Chief Minister's Comprehensive Health Insurance Scheme as follows:

4.	Non-Invasive ventilation (CPAP/ Bi-PAP) in intensive care unit	Rs. 30000/-
5.	ICU with O2 only as stepping down	Rs. 25000/-

F) The Package cost for Covid-19 treatment will be revised as per the characteristic of the transmission of covid-19 by two months.

 Private hospitals should not collect charges more than the fixed rate. If excess charge will be collected, the aggrieved person may submit a complaint at the Chief Minister's Comprehensive Health Insurance Scheme's toll-free telephone number- 1800 425 3993 and 104

* If the complaint is proved with appropriate evidences, suitable action will be taken against the hospitals under Tamil Nadu Medical Institutions Regulations Act (Clinical Establishment Act) and the Disaster Management Act (Disaster Management) which are practiced.
