State Health Society – Tamil Nadu – Civil works – Construction of New Buildings to 39 Health Sub Centres during 2013-14 – Sanction of Funds - Orders - Issued.

1. G.O. (Ms) No.116, Health and Family Welfare (EAP-II)Department, dated 25.03.2011.
2. From the Mission Director, State Health Society, Letter No.5848/SHS/S/2013-1, Dated: 14.07.2013.

ORDER:

The Mission Director, State Health Society in his letter 2nd read above has stated that it has been proposed to upgrade the infrastructure in Health Sub Centres(HSCs) to facilitate the Village Health Nurses(VHNs) to stay in the villages to serve the rural poor in better ways in all health activities. It is proposed to construct new buildings in the year 2013-14 for 210 Health Sub Centres which do not have their own buildings. In this regard, a detailed proposal for the construction of 210 new Health Sub Centres buildings was included in Project Implementation Plan(PIP) 2013-14 and the National Project Coordination Committee (NPCC) had approved the proposal for the construction of 39 new HSC buildings in the High Priority Districts, with initial allocation of funds of Rs.292.50 lakh. As the non recurring cost for the construction of building to these Health Sub Centres at Rs.15.00 lakh each was approved at 50% for the year 2013-14, the balance is to be proposed in the PIP for the year 2014-15.

2. The Mission Director, State Health Society has stated further that as per the orders issued in the G.O. (Ms) No.116, Health and Family Welfare (EAP-II)Department, dated 25.03.2011 the funds approved by Government of India for civil works under National Rural Health Mission(NRHM) have to be remitted to Government account under receipt head and the funds have to be drawn by the executive authority – the Public Works Department (PWD) for the execution of the works. He has requested the Government to sanction funds for the construction of new buildings to 39 Health Sub Centres.

3. The Government after careful consideration has decided to accept the proposals of the Mission Director, State Health Society and they accordingly issue the following orders:

- i. The Mission Director, State Health Society is permitted to construct new buildings to 39 Health Sub Centres indicated in the annexure to the Government Order at a total cost of Rs.5,85,00,000/-
- ii. Sanction is accorded to an amount of Rs.5.85 crore (Rupees five crore and eighty five lakh only) to the Chief Engineer (Building), Public works Department, Chennai-5 for construction of new building to 39 Health Sub Centres indicated in the annexure to this Government Order at the rate of Rs.15.00 lakh per Health Sub Centres as per the proceedings of the Mission Director, State Health Society.
- iii. The Mission Director, State Health Society, Tamil Nadu, Chennai is permitted to remit the funds of Rs.292.50 lakh approved in PIP 2013-14 for the above civil works into the following Government receipt head:

"0210-Medical and Public Health 02-Rural Health Service –
800 other Receipts AD Receipts from Government of India for
National Rural Health Mission Works
(DPC 0210-02.800-AD – 0002)"

He should remit the balance amount of Rs.292.50 lakh after approval by the Government of India in PIP 2014-15 to the above Government account and send a report to the Government.

- iv. The Mission Director, State Health Society, is permitted to change the Health Sub Centres for the construction of new building and cost of work on the basis of availability of site and local requirements subject to not exceeding the total funds approved.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:
