From the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy, letter Ref.No.3286/P&D-1/2012, dated 19.01.2015.

ORDER:

The Principal Secretary and Commissioner of Indian Medicine and Homoeopathy has stated that Government Ayurveda Medical College and Hospital, Kottar, Kanyakumari is functioning with an annual intake of 50 students and it is governed by Central Council of Indian Medicine (CCIM). The Central Council of Indian Medicine has prescribed the Minimum Standard Requirements for the Siddha, Ayurveda and Unani colleges to get permission for admitting students every year.

2. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that Minimum Standard Requirements prescribed by Central Council of Indian Medicine norms contains nine Modern Medical faculties viz., Medical Specialist, Medical Surgeon, Obstetrician and Gynecologist, Pathologist, Anesthesiologist, Ophthalmologist, Pediatrician, Radiologist and Dentist for taking classes and the Minimum Standard Requirements insists that these faculties shall have to be availed either on contract or part time basis. These specialist are posted to the College on deputation basis from Director of Medical Education side at the time of Central Council of Indian Medicine inspection to fulfill the norms.

3. The Principal Secretary and Commissioner of Indian Medicine and Homoeopathy has requested the Government to create one Anesthesiologist post of Modern Medicine on the honorarium of Rs.8000/- per month to the Government Ayurveda Medical College and Hospital, Kottar, Nagercoil, Kanyakumari District on the same lines of Government Siddha Medical College, Chennai and also stated that the existing system of posting of Modern Medical Specialists from Director of Medical Education side will be continued in respect of all other Modern Medicine Specialist.

4. The Government have examined the proposal of the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy and accord sanction for creation of one post of Anesthesiologist of Modern Medicine on honorarium of Rs.8000/- per month

(Rupees Eight thousand only) to the Government Ayurveda Medical College and Hospital, Kottar, Kanyakumari District to fulfill the Central Council of Indian Medicine norms.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

Necessary funds of Rs.56,000/- (Rupees Fifty six thousand only) will be provided in Revised Estimate / Final Modified Appropriation 2015-16 Pending provision of funds, the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy is authorized to incur the expenditure. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy is requested to include the expenditure, while sending Revised Estimate / Final Modified Appropriation 2015-16 proposals to Government in Finance (Health-I) Department without fail.
