## ORDER:

The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have released Grants-in-aid to State Government for Asha Benefit Packages during 2020-2021 and credited into State Government account for drawal of amount through treasury as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.1,41,00,000/- (Rupees One Crore and Forty One Lakh only) works out of Rs.94,00,000/- (Rupees Ninety Four Lakh only).

- 2. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.2,35,00,000/- (Rupees Two Crore and Thirty Five Lakh only) towards the State and Central Share contribution of Grants-in-Aid for Asha Benefit Packages during the year 2020-21 and to authorize him to draw the above amount under National Health Mission through treasury mode and credit into National Health Mission Account.
- 3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.2,35,00,000/- (Rupees Two Crore and Thirty Five Lakh only) towards the State and Central Share contribution (State share Rs.94,00,000/- and Government of India share Rs.1,41,00,000/-) of the Asha Benefit Packages during the year 2020-2021.
