ORDER:

Recent research findings indicate that certain diseases can be easily cured through stem cell therapy. In the Government sector, in the medical field, the Government Stanley Hospital, Chennai has initiated the stem cell research in the Hospital. However, the findings of the research need to be deliberated in an appropriate forum, so as to extend them to the clinical trials and thereafter to disseminate in the field among patients. The Government considers that there should be concerted efforts to get the expected results and it is necessary to constitute a Steering Committee to monitor the progress of the research programmes on stem cell therapy.

2) The Government have therefore decided to constitute a Steering Committee for the above purpose, with terms of reference. Accordingly the Government hereby order to constitute the following Steering Committee with the terms of reference as detailed below:-

Terms of reference for the Committee

- Monitoring the progress of current research programmes undertaken by various Government institutions.
- Facilitation for establishment of a Current Good Manufacturing Practices (CGMP) facility and its validation.
- Guiding the Medical College authorities to get Licence/Approval for the clinical trials from designated Government regulatory bodies like Drugs Controller General of India (DCGI), etc.
- Coordination with other agencies doing research in the same field to bring them to a logical conclusion.
- Applying for New Research projects for funding to Department of Biotechnology / Department of Science and Technology / Indian Council of Medical Research or other funding agencies.
- Review of progress clinical trials among patients.
- Formulation of new research proposals.

The committee shall meet once in six Months.
