#### ORDER:

The Mission Director, State Health Society in the letter 2nd read above has stated that the Central funds under the Centrally Sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State Plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India in their letter read above have transferred and credited a sum of Rs.11,95,50,000/- (Rupees Eleven crore ninety five lakh and fifty thousand only) into State Government account as its 75% share of Grants in Aid for the financial year 2015-16 for the National Vector Borne Disease Control Programme as mentioned below:-

The Government of India has requested to ensure 25% State contribution based on the release of funds by Government of India.

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State Share against the 75% of the Government of India release Rs.11,95,50,000/- (Rupees Eleven crore ninety five lakh and fifty thousand only) works out to Rs.3,98,49,999/- (Rupees Three crore ninety eight lakh forty nine thousand nine hundred and ninety nine only) Since Government of India has transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of Central Share and State Share will have to be the Government has requested Budget. He State to issue orders to release a sum of Rs.15,93,99,999/- (Rupees Fifteen core ninety three lakh ninety nine thousand nine hundred and ninety nine only) towards release of Central and State contribution of Grants in aid to the State Health Society under National Vector Borne Disease Control Programme for 2015-16 and to authorize the Mission Director, State Health Society/ Project Director Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.15,93,99,999/- (Rupees Fifteen crore ninety three lakh ninety nine thousand nine hundred and ninety nine only) under National Health Mission through Treasury mode.

- 3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.15,93,99,999/- (Rupees Fifteen crore ninety three lakh ninety nine thousand nine hundred and ninety nine only) i.e., Rs.11,95,50,000/- (Rupees Eleven Crore ninety five lakh and fifty thousand only) being 75% Central Share and Rs.3,98,49,999/- (Rupees Three crore ninety eight lakh forty nine thousand nine hundred and ninety nine only) being 25% of the State share as matching grant to the State Health Society, Tamil Nadu to implement the National Vector Borne Disease Control Programme during the year 2015-16.
