ORDER:-

The Director of Medical and Rural Health Services in his letter read above, has stated that their directorate is the basic unit and a prime factor in providing quality Health Care at secondary level in the State of Tamil Nadu and it has a distinctive history of more than 93 years and their department is entrusted with the responsibility of providing secondary level medical care to the public through its network of hospitals located throughout the Urban, Semi Urban and Rural landscape of the State. He has also stated that Comprehensive Emergency Obstetrics and Newborn Care (CEmONC) services in 105 hospitals including all District Headquarters Hospitals and Newborn Stabilization Units (NBSUs), Sick Neo-natal Care Units (SNCUs) have been established in 114 hospitals and 42 hospitals respectively and providing remarkable services. He has also further stated that vehicle No.TN-05-D-0010 and TN-05-S-0009, Ambassador cars attached to their directorate have been condemned under normal conditions. The Director of Medical and Rural Health

Services, has therefore requested the Government to sanction two new vehicles ("TATA SUMO GOLD") at a cost of Rs.6.00 Lakhs each.

2. The Government have examined the proposal of the Director of Medical and Rural Health Services carefully and have decided to accept it. Accordingly sanction is accorded for a sum of Rs.10,93,436/- (Rupees Ten Lakhs Ninety Three thousand Four hundred and thirty six only) towards the purchase of two cars("Tata Sumo Gold") at a cost of Rs.5,46,718/- each as per the quotation price, for the use of the Directorate of Medical and Rural Health Services, Chennai, in lieu of the two old condemned vehicles.

3. The expenditure sanctioned in para 2 above shall be debited to the following Head of Account:

4. The expenditure sanctioned in para 2 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders of the sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical and Rural Health Services is requested to send necessary explanatory notes to include the above expenditure in the Revised Budget Estimates 2016-2017 Supplementary Estimate for the year 2016-2017 to Finance Department at the appropriate time without fail.

5. This order issues with the concurrence of the Finance department vide its U.O No.84/ADS (Dr.Pu) /H-II/16, dated:04.03.2016 and ASL No.2579 (Two Thousand Five Hundred and Seventy Nine).


