ORDER:

In G.O. (Ms) No, 366 Health and Family Welfare (P2) Department dated 20.11.2014 orders were issued sanctioning an amount of Rs. 67.00 crore (Rupees Sixty Seven Crore only) towards the distribution of the "Amma Baby Care Kit" and the funds required will be diverted from the savings available under Dr. Muthulakshmi Reddy Maternity Benefit Scheme and additional funds will be provided based on the requirement. The "Amma Baby Care Kit" shall be given to all new born babies, born in Government Health facilities. It was ordered in the above said Government Order that the gift items shall be procured centrally through Tamil Nadu Medical Services Corporation Limited and supplied through its drug warehouses. The Director of Public Health and Preventive Medicine has been directed to prepare the operational guidelines in this regard.

- 2) The Director of Public Health and Preventive Medicine has stated that the Board of Directors of Tamil Nadu Medical Services Corporation Limited has decided in its 118th Board meeting to authorize him to send necessary proposals to seek exemption from the tender process for the procurement of Sowbagyasunti Lehiyam, one among the items in the Amma Baby Care Kit from TAMPCOL directly under section 16(f) of the Tamil Nadu Transparency in Tenders Act 1998. He has requested the Government to accord necessary permission to Tamil Nadu Medical Services Corporation Limited to procure Sowbagyasunti Lehiyam from the TAMPCOL directly in exemption of the tender process.
- 3) The Government after careful examination accord permission to the Managing Director, Tamil Nadu Medical Services Corporation Limited and grant exemption for

procurement and supply Sowbagyasunti Lehiyam under section 16(f) of the Tamil Nadu Transparency in Tenders Act 1998 from the TAMPCOL Limited.

- 4) Based on the orders issued in para 3 above, necessary notification in this regard under clause (f) of Section 16 of the Tamil Nadu Transparency in Tenders Act 1998 (Act 43 of 1998) will be issued by the Finance (Salaries) Department separately.
- 5) This order issues with the concurrence of the Finance Department vide its U.O. No.140/ADS(Dr.PU)/2015 dated 27.8.2015.
