ORDER:-

The Hon'ble Chief Minister has made an announcement on 25.08.2015, under Rule 110 of the Tamil Nadu Legislative Assembly Rules, among others, that a sum of Rs.6.05 crore will be sanctioned for the construction of Hostel Building for students in the School of Nursing in Government Theni Medical College, Theni.

2. The Director of Medical Education, in the letters read above, has stated that the plan for the proposed Hostel building for 200 students in the School of Nursing has been prepared as per Nursing Council of India norms with a total plinth area of 3052.66 sq.m. of which 1137.26 sq.m. for ground floor, 1021.63 sq.m. for first floor and 893.77 sq.m. for second floor.

3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Madurai Region based on the schedule of rates for the year 2014-2015 and has requested the Government to accord administrative and financial sanction for a sum of Rs.5.50 crore and Rs.6.05 crore for 2015-2016 by adding 10% escalation for the construction of Hostel Building for 200 students in the School of Nursing in Government Theni Medical College, Theni.

4. The Government after careful examination, accept the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.6,05,00,000/- (Rupees six crore and five lakh only) for the construction of Hostel Building for 200 students in the School of Nursing in Government Theni Medical College, Theni in the schedule of rates for the year 2015-2016.

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

"4210 - Capital Outlay on Medical and Public Health - 01 Urban Health Services – 110 - Hospitals and Dispensaries (including Pharmacy) - Schemes in the Twelfth Five Year Plan-II- State Plan – JA- Buildings 16 Major Works. (DPC 4210-01-110-JA-1602)"

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of the legislature will be obtained in due course. Pending approval of legislature, the expenditure may be initially met by an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next supplementary estimate and apply for sanction of an advance from the Contingency Fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Chief Engineer (Buildings) is also requested to send necessary explanatory notes to include the above expenditure in the supplementary estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.43783/Health-II/2015, dated 11.08.2015 and ASL No.718 (Seven hundred and eighteen).
