#### ORDER:

In the Government Order fourth read above, permission was granted to the Chairman, Kovai Medical Centre Research and Educational Trust, Coimbatore to start Bachelor Occupational Therapy course with an annual intake of 50 (Fifty) candidates from the academic year 1993 -1994.

2. In the Government Order fifth read above, permission was granted to the Chairman, Kovai Medical Centre Research and Educational Trust , Coimbatore to start Bachelor of Physiotherapy Degree course with an annual intake of 50 (Fifty) candidates from the academic year 1993 -1994.

3. The Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore has requested the Government to grant permission to shift the KMCH College of Physiotherapy and Occupational Therapy Colleges, Coimbatore from KMCH Campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District.

4. In its Government letter sixth and seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed paramedical institutions has fulfilled the conditions prescribed by the Government in the Government Orders first to third read above and the Tamil Nadu Dr. M.G.R. Medical University, Chennai.

In his letter eighth read above, the Director of Medical Education has submitted the proposal, in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Tamil Nadu Dr. M.G.R. Medical University, Chennai. Hence, the Director of Medical Education has recommended to give permission to the Managing Trustee, Kovai Medical Center Research and Educational Trust, Coimbatore to shift the KMCH College of Physiotherapy and Occupational Therapy Colleges, Coimbatore from KMCH Campus, Avinashi Road, Coimbatore to S.F.Nos.259 & 267, Kalapatti Village, Coimbatore North Taluk, Coimbatore District.
