#### ORDER:

The Hon'ble Chief Minister has made an announcement on 25.08.2015, under Rule 110 of the Tamil Nadu Legislative Assembly Rules, among others, a sum of Rs.4.63 crore will be sanctioned for the construction of Residential Quarters at Government Chengalpattu Medical College, Chengalpattu and a sum of Rs.3.15 crore will be sanctioned for the construction of Residential Quarters for 30 students and Lecture Hall for 400 students at Government Thiruvarur Medical College, Thiruvarur.

- 2. The Director of Medical Education has sent the proposal for the construction of "A", "C" and "D" type Residential Quarters for faculty and other administrative staff at Chengalpattu Medical College, Chengalpattu.
- 3. The Director of Medical Education has stated that as per Medical Council of India norms, quarters should be made available to 20% of teaching staff. There is no residential quarters for faculty and other administrative staff in the Chengalpattu Government Medical College, Chengalpattu. She has further stated that the plan evolved by the Chief Architect, Public Works Department, Chennai, for 'A', 'C' and 'D' type Residential Quarters for Government Medical College at Thiruvannamalai has been adopted for proposed 'A', 'C' and 'D' type Residential Quarters for Government Medical College at Chengalpattu to accommodate 26, 3 and 9 residents respectively.
- 4. The Director of Medical Education, has therefore, requested the Government to accord administrative and financial sanction for the construction of 'A', 'C' and 'D' type Residential Quarters for faculty and other administrative staff at Chengalpattu

Medical College, Chengalpattu at an estimated amount of Rs.220.00 lakh, Rs.39.60 lakh and Rs.203.50 lakh respectively in the schedule of rates for the year 2015-2016. She has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Chennai.

5. The Government have examined the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs.4,63,10,000/- (Rupees four crore sixty three lakh and ten thousand only) for the construction of 'A', 'C' and 'D' type Residential Quarters for faculty and other administrative staff at Chengalpattu Medical College, Chengalpattu in the schedule of rates for the year 2015-2016 as detailed below:-

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health - 01 Urban Health Services - 110 - Hospitals and Dispensaries (Including Pharmacy) - Schemes in the Twelfth Five Year Plan - II State Plan - JA Buildings - 16 Major Works" (DPC 4210-01-110-JA -1602)

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary Estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department.

The Chief Engineer (Buildings) shall send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2015-2016 to Government in Finance Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.43498/Health-II/2015, dated:11.08.2015 and ASL No.726 (Seven hundred and twenty six).
