## ORDER:

Dr. V.Shanta, Chairman, Cancer Institute, Adyar in her letter first read above, has sent proposal to Government for approving the upgradation of the Cancer Institute of Adyar as Centre of excellence. The Government of Tamil Nadu have recommended the same proposal to the Government of India for their consideration.

- 2. Based on the acceptance conveyed by the Government of India, a detailed project proposal submitted by Cancer Institute as per prescribed norms by National programme for Prevention and Control of Cancer, Diabetes, Cardio vascular Disease & Stroke (NPCDCS) was recommended by this Government to Government of India.
- 3. The Director, Cancer Institute, Adyar has submitted revised tripartite Memorandum of Understanding (MoU) for the amount of Rs.120.00 crore (One hundred and twenty crore only) which was sent to Director, Ministry of Health and Family Welfare, Government of India, New Delhi.
- 4. The Government of India in their order second read above, have released the first instalment grants to the Cancer Institute, Adyar for setting up of State Cancer Institute under Tertiary Care Cancer Centre Scheme for purchase of equipments/ construction activities of under National programme for Prevention and Control of Cancer, Diabetes, Cardio vascular Disease & Stroke (NPCDCS) during 2014-15. The components of Central Share and the details of first instalment are as follows:

- careful consideration, sanction a sum of 6. The Government after Eighty nine crore eighty four lakh Rs.89.84.00.000/- (Rupees i.e., Rs. 67,38,00,000/- (Rupees Sixty seven crore thirty eight lakh only) as first being 75% of the Government of India grants-in-aid and instalment and Rs.22,46,00,000/- (Rupees twenty two crore forty six lakh only) being 25% of State Share to upgrade the Adyar Cancer Institute as State Cancer Institute under the National Programme for Prevention and Control of Cancer, Diabetes, CVD and Stroke (NPCDCS) for the year 2014-15, subject to the terms and conditions prescribed in Memorandum of Understanding (MoU) and also subject to the following terms;
  - a) The recurring cost to be met by the Adyar Cancer Institute itself (If any from new project)
  - b) The extent of free treatment being given a relook, considering the huge investment afresh by Government of India/Government of Tamil Nadu.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following Head of account:-
  - "2210 Medical and Public Health 80 General 800 Other Expenditure I Non Plan – AD Grants to Private Medical Institution under the Control of Director of Medical Education – 09 Grants-in-Aid-01 Grants for current Expenditure" (DPC 2210-80-800-AD 0915)

- 8. The Director of Medical Education is authorized to draw and disburse the above expenditure in favour of Cancer Institute Adyar.
- 9. Necessary funds will be directly included in the first Supplementary Estimates 2015-16. The Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 6 above, after the first Supplementary Estimate Bill 2015-16 is passed in the Legislative Assembly. The Director of Medical Education is directed to send necessary explanatory notes to include, this expenditure in the first Supplementary Estimates 2015-16 to Government in Finance Department without fail.
