#### **ORDER:**

In the circumstances reported by the Director of Medical Education, Chennai the following amendments are issued to the Government Order first read above:-

#### **AMENDMENT**

- i. The following provision mentioned under item (iv) of Annexure to G.O (Ms) No.219, Health and Family Welfare (PME) Department, dated: 06.06.2018 shall be deleted;
  - (a) Metro Areas : 3 acres
  - (b) District Headquarters /Corporation/  
Municipality Areas : 5 acres
  - (c) Rural Area : 7 acres

- ii. The following provision under item (iv) of Annexure to above Government Order shall be substituted;
- a) Metro Areas : 1 acre
- b) District Headquarters /Corporation/ Municipality Areas : 2 acres
- c) Semi Urban or Rural Area : 3 acres
- iii. Further, the provision to obtain building completion certificate issued by the Competent Authority ie. PWD as mentioned in item (vi) shall also be substituted with the following provision as suggested by the Director of Medical Education:-

"The Building Completion Certificate may be obtained from the Plan Approval Authority"
