ORDER:

In the Government order first read above, the Government have sanctioned a sum of Rs.1.00 crore towards the purchase of one Digital X-ray Machine to the Government Hospital of Thoracic Medicine, Tambaram sanatorium, Chennai.

2. In the letters second read above, the Director of Medical Education has stated that the Superintendent, Government Hospital of Thoracic Medicine, Tambaram Sanatorium, Chennai had stated that the Tamil Nadu Medical Services Corporation Limited (TNMSC) purchased a Digital X-ray Machine from M/s.Cura Health Care Private Limited at a cost of Rs.79,86,200/- (including advertisement charges). In this connection, the Superintendent, Government Hospital of Thoracic Medicine, Tambaram Sanatorium, Chennai has requested the Managing Director, Tamil Nadu Medical Services Corporation Limited, Chennai to procure the Picture Archiving and Communication System (PACS) from the balance amount of Rs.20,13,800/-. He has also stated that the above said balance amount of Rs.20,13,800/- has been remitted into the Government account on 07.11.2017. Hence, the Director of Medical Education has requested the Government to issue administrative and financial sanction for a sum of Rs.20,13,800/- for the procurement of the Picture Archiving and Communication System (PACS) to the Government Hospital of Thoracic Medicine, Tambaram Sanatorium, Chennai.

3. The Government after careful examination of the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.20,13,800/- (Rupees Twenty lakhs Thirteen thousand and Eight hundred only) for the procurement of the Picture Archiving and Communication System (PACS) to the Government Hospital of Thoracic Medicine, Tambaram Sanatorium, Chennai.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“2210. Medical and Public Health – 01. Urban Health Services – Allopathy – 110. Hospital and Dispensaries – State’s Expenditure – JJ. Improvements of Teaching Hospitals – 19. Machinery and Equipments – 01. Purchase (D.P.C 2210 – 01- 110- JJ- 1911)

5. Necessary funds will be provided in the RE/FMA 2017-2018, pending provision of funds, the Director of Medical Education is authorized to draw and utilize the amount sanctioned in para 3 above. However this expenditure will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates for 2017-2018. The Director of Medical Education is directed to include this item of expenditure while sending the proposal for RE/FMA 2017-2018 and also send necessary draft explanatory notes for inclusion of expenditure in Supplementary Estimates 2017-2018 to the Government in Finance Department without fail.

6. This order issues with the concurrence of the Finance Department vide its U.O.No.1211/Health-II/2018, dated: 17.01.2018 and ASL No.2476 (Two thousand four hundred and seventy six).
