The Director, (i/c) Tamil Nadu State Health Transport Department, Chennai, in his letter read above has stated that the land measuring 0.05.5 Hectares was allotted in survey No.66/4 at Vada Andappattu Village in Thiruvannamalai District for accommodating Mobile Workshop at Thiruvannamalai District for Tamil Nadu State Health Transport Department by Thiruvannamalai District collector. He has further stated that the Workshop building has to be constructed in the Land allotted for effectively maintaining in and around to the Vehicles of various offices of Health and Family Welfare Department functioning in Thiruvannamalai District. It has been estimated by the Public Works Department for the construction of the said Workshop building at a cost of Rs.33.00 Lakhs (Rupees Thirty three Lakhs only) under Part-II Scheme for the year 2014- 2015.

2. The Director, (i/c.) Tamil Nadu State Health Transport Department, Chennai has therefore requested to sanction a sum of Rs.33.00 Lakhs (Rupees Thirty three Lakhs only) towards the Construction of Workshop Building for Mobile Workshop (H), at Thiruvannamalai District for under Part-II Scheme 2014-2015.

3. Sanction is accorded to incur an expenditure of Rs.33.00 Lakhs (Rupees Thirty three Lakhs only) towards the Construction of Workshop Building for Mobile Workshop (H), at Thiruvannamalai District for Tamil Nadu State Health Transport Department under Part-II Scheme for the year 2014- 2015.


