#### **ORDER:**

In the Government Order second read above, the Government accorded permission to the Director of Medical Education to fill up 25% of the vacancies in the post of Reader/Professor in all Government Medical Colleges in the specialised Department on contract basis on consolidated pay by appointing the retired Readers / Professors (on Superannuation) in addition to pension as per the procedures laid down in the Government Order first read above.

- 2. In the Government Order third read above, the Government have issued orders enhancing the consolidated amount of the retired faculties appointed on contract basis besides pension for a period of five years under the control of the Director of Medical Education for certain specialities in the Clinical and Non-clinical areas mentioned therein from Rs.50,000/- to Rs.70,000/- per month.
- 3. In the Government Order fourth read above, the Government have sanctioned a sum of Rs.8,40,155/- in the financial year 2014-2015 towards the consolidated pay for the posts of Professors of Community Medicine and Anatomy.

- 4. In the Government Order fifth read above, orders have been issued enhancing the consolidated pay of the retired Medical Officers who are appointed on contract basis from Rs.70,000/- to Rs.90,000/- per month besides pension in Clinical and Non-Clinical specialities mentioned in the Government Order third read above.
- 5. The Director of Medical Education has requested the Government to accord financial sanction for a sum of Rs.28,02,000/- for the three posts of Professors of Anatomy, Community Medicine and Physiology Department on contract basis on consolidated pay in the Medical Colleges under the control of Director of Medical Education for the financial year 2015-2016 as mentioned in the annexure to this order.
- 6. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for a sum of Rs.28,02,000/- (Rupees twenty eight lakh and two thousand only) for the payment of consolidated pay to the three posts of Professors of Department of Anatomy, Community Medicine and Physiology working on contract basis in the Medical Colleges under the control of Director of Medical Education for the period as mentioned in the annexure to this order.
- 7. The expenditure shall be debited to the Head of Account as mentioned in this annexure to the order.
- 8. Necessary additional funds will be provided in the Revised Estimate / Final Modified Appropriation 2015-2016 to meet the expenditure sanctioned in para 6 above. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimate 2015-2016. Pending provision of such funds in Revised Estimate / Final Modified Appropriation 2015-2016, the Director of Medical Education is authorized to draw and disburse the amount and she is requested to include the expenditure sanctioned above while sending the budget proposal for Revised Estimate / Final Modified Appropriation and Supplementary Estimate 2015-2016, to Government in Finance (Health-II) Department without fail.
- 9. This order issues with the concurrence of Finance Department vide its U.O.No.45953/Health-II/2015, dated 01.09.2015 and ASL No.882 (Eight hundred and eighty two).
