#### ORDER:-

In the letter read above the Director of Medical and Rural Health Services has stated that the Government Hospital, Arcot, Vellore District is functioning with 82 sanctioned bed strength. An average of 800-900 out patients and 85 in patients are treated per day at this hospital. He has also stated that there is only one Pharmacist post sanctioned to this Taluk Hospital. The routine works i.e. disbursing drugs to the huge attendance of OP patients and the IP patients, attending post mortem with the Doctors, looking after the maintenance of surgical stores and medical stores, Registering the distribution of drugs in the appropriate register, preparing the condemnation proposals, purchasing medicines and surgical from Tamil Nadu Medical Services Corporation warehouse, taking timely action to get the break down equipments repaired etc., have to be looked after by the Pharmacists. At present all these above works in Government Hospital, Arcot are carried out by a single Pharmacist and it is very difficult to face the routine hospital works like handling of drugs and other related works. He has also stated that as per the medical code norms this Hospital has to be sanctioned with the strength of 8+1 Pharmacists.

2. The Director of Medical and Rural Health Services has requested the Government to sanction three new Pharmacist posts to the Government Hospital, Arcot, Vellore District for the uninterrupted and smooth functioning of the Hospital and to avoid any criticism from the Press, Public and Media etc.,

3. The Government after careful examination, accord sanction for creation of one post of Pharmacist in time Scale of Pay of Rs.9300-34800+G.P.4200 to the Government Taluk Hospital, Arcot, Vellore District at an average annual recurring cost of Rs.6,84,144/- (Rupees Six Lakhs Eighty Four

Thousand One Hundred and Forty Four only) for the period of one year from the date of filling up of the post.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

"2210-Medical and Public Health – 01-Urban Health Services - Allopathy-110 – Hospitals and Dispensaries – I Non Plan AB Taluk Head Quarters Hospital - 01 Salaries".
