ORDER: -

In the letter second read above the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that due to constraint of time, he has directly submitted proposal to Government of India, seeking financial assistance for the supply of essential drugs to 398 (out of which 369 are Siddha Wings, 23 are Ayurveda Wings and 6 are Homoeopathy wings) ISM Wings in the State other than those already sanctioned in 134 Primary Health Centres scheme and 300 wings under National Rural Health Mission scheme. The total financial assistance sought was Rs. 1,97,50,000/-. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that the Government of India in their letter dated 21.10.2009 have accorded sanction for the provisional payment of Rs.1,97,50,000/- and released a sum of Rs.1,67,88,000/- being their 85% share and the remaining 15% to be borne by the State Government towards the purchase of essential drugs to 392 Ayurveda (it is stated as Ayurveda instead of Siddha and Ayurveda in the GoI letter) Dispensaries @ Rs. 50,000/- per wing and 6 Homoeopathy wings @ Rs. 25,000/- per wing.

2. Further the Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has stated that the 85% of Government of India share has already been received in the Directorate through State Health Society (IM) account maintained with State Bank of India, Aminjikarai, Chennai. To utilize this grant provided by Government of India in full, the State Government shall have to release their 15% share of the total provision as per the precondition of the operational guidelines of the Government of India. The details of State share are as follows:-

The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy has therefore, requested the Government to sanction 15% of the State share of Rs.29,62,500/- (Rupees Twenty nine lakhs sixty two thousand and five hundred only) towards the purchase of essential drugs to 398 ISM wings in State Rural and Backward area Dispensaries under the Centrally Sponsored Scheme of Main streaming of AYUSH under National Rural Health Mission during 2009-2010.

4. The Government have carefully examined the proposal of Principal Secretary / Commissioner of Indian Medicine and Homoeopathy and accord sanction a sum of Rs.29,62,500/- (Rupees Twenty nine lakh sixty two thousand and five hundred only) at State share of 15% towards the purchase of essential drugs to 398 wings in State Rural and Backward area dispensaries under the Centrally Sponsored Scheme of main streaming of AYUSH under National Rural Health Mission during 2009-2010.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"2210 – Medical and Public Health – 04 Rural Health Services – Other systems of Medicines 800. Other Expenditure – Schemes in the Twelfth Five Year Plan – VI Schemes Shared between State and Centre – UA. Strengthening of AYUSH System under National Rural Health Mission Scheme – 66 Medicine. (DPC 2210- 04- 800 UA 6604).

6. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriate 2015-2016. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimates 2015-2016. Pending provision of funds in the Revised Estimate 2015-2016, the Principal Secretary/Commissioner of Indian Medicine and Homoeopathy department is authorized to incur the amount sanctioned in para 4 above. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy Department is requested to send draft explanatory notes for Supplementary Estimates 2015-2016 to Government in Finance (BG-II) Department and also to include the expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriate 2015-2016 to Government in Finance (Health-I) Department without fail.

7. This order is issued with the concurrence of Finance Department vide its U.O. No.47665/Health-I/ 2015 , dated 01.09.2015 and ASL No. 865 (Eight hundred and sixty five).
