ORDER:

In the Government Order first read above, the Government accorded administrative and financial sanction for the construction of Centenary Block building at Coimbatore Medical College Hospital, Coimbatore for a sum of Rs.50,00,00,000/- and in the Government Order second read above, the Government accorded revised administrative sanction for the above work for a sum of Rs.57,19,69,000/-.

2. The Director of Medical Education, in the letter third read above, has sent the proposal for providing additional amenities to Centenary Block building at Coimbatore Medical College Hospital, Coimbatore.

3. The Director of Medical Education has stated that the detailed estimate was prepared within administrative sanction of Rs.50,00,00,000/- by reducing some of the lumpsum provisions from actual requirement. Most of the lumpsum provisions which are actually required could not be provided in the detailed estimate. Based on that, the estimate for the additional amenities to Coimbatore Medical College Hospital, Coimbatore has been prepared by adopting the schedule of rates for the

year 2014-2015 for necessary administrative and financial sanction of the Government as detailed below:-

The Director of Medical Education has countersigned and forwarded the rough cost estimate for providing additional amenities to Centenary Block building in Coimbatore Medical College Hospital, Coimbatore, prepared by the Engineer in Chief (Buildings) and Chief Engineer (Buildings), Chennai Region based on the schedule of rates for the year 2014-2015 and the estimate amount has been worked out to Rs. 4,39,00,000/-.

5. The Director of Medical Education has requested the Government to accord administrative and financial sanction for providing additional amenities to Centenary Block building in Coimbatore Medical College Hospital, Coimbatore for an amount of Rs.4,39,00,000/- as the lumpsum provision works are found to be actually/essentially required and to be executed for the effective utilization of the building.

6. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education. Accordingly, the Government accord administrative and financial sanction for a sum of Rs.4,39,00,000/- (Rupees four crore and thirty nine lakh only) for providing additional amenities to Centenary Block building at Coimbatore Medical College Hospital, Coimbatore in the schedule of rates for the year 2014-2015.

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-
