

Compensation – Enhancement of compensation amount from Rs.3.00 lakhs to Rs.5.00 lakhs (Rupees five lakhs only) to the families of the deceased persons Tvl.S.Baskar and K.Samsuddin who were affected by HCV at Government Stanley Medical College Hospital, Chennai during dialysis - Orders - Issued.

ORDER:

In the Government Order second read above, orders were issued sanctioning compensation of Rs.3.00 lakhs to each of the 16 patients (amounting to a total sum of Rs.48.00 lakhs only) who were alleged to have been affected with HCV infection during the course of dialysis in the Government Stanley Medical College Hospital, Chennai as a special case as per the interim order of the Hon'ble High Court of Madras in W.P.No.5228/2015, dated.20.04.2015 filed by Thiru.Jayaram Venkatesan and the compensation amount has also been disbursed to the individuals / families of the deceased. Out of the 16 patients who were infected by HCV, two patients' viz.Tvl.S.Baskar and K.Samsuddin expired during the course of the case.

- 2) The Hon'ble High Court in its interim order dated.29.6.2015 in W.P. No.5228/2015 has ordered that the respondents / authorities will also examine the enhancement of interim compensation to the two persons who are stated to have passed away viz., Tvl.S.Baskar and K.Samsuddin.
- 3) The Government after careful examination decided to accept the orders of Hon'ble High Court and enhance the compensation amount from Rs.3.00 lakhs to Rs.5.00 lakhs (Rupees five lakhs only) to each of the families of the deceased persons Tvl.S.Baskar and K.Samsuddin and to release the balance of Rs.2.00 lakhs (Rupees two lakhs only) (amounting to a total sum of Rs.48.00 lakhs only) to each of the families of the persons said to have been deceased during the course of the case and order accordingly.

- 4. The amount sanctioned in para 3 above towards payment of compensation shall be debited to the following head of account:-
 - "K. Deposits and Advances (b) Deposits not bearing interest 8443-00 Civil Deposits 800. Other Deposits AU Corpus Fund for payment of Compensation awarded by courts on the cases filed against Government Doctors." (DPC.8443 00 800 AU 0003 (outgo.))
- 5. The Director of Medical Education, Chennai-10 is authorized to draw and disburse the compensation amount to the legal heirs of Tvl.S.Baskar and K.Samsuddin with valid proof of receipt and by following usual procedure.
- 6. This order issues with the concurrence of the Finance Department vide its U.O.No.48643/Health-II/2015, Dated.07.09.2015.
