### **ORDER:**

In Government Order first read above, a sum of Rs.72.35 lakhs has been sanctioned to the Tamil Nadu State AIDS Control Society for the functioning of the District AIDS Prevention control Units at Ariyalur and Tiruppur districts for the years 2014-2015, 2015-2016 and 2016-2017.

2. The Project Director, Tamil Nadu State AIDS Control Society in his letter second read above has stated that based on the above orders, a sum of Rs.72.35 lakhs has been drawn and disbursed by the Director of Medical Education, Chennai.

3. The Project Director, Tamil Nadu State AIDS Control Society has stated that National AIDS Control Organisation (NACO), New Delhi has approved the functioning of 27 Districts AIDS Prevention Control (22 Category "A +5 Category 'B' ) in Tamil Nadu. Hence, in the 67<sup>th</sup> Executive Committee Meeting of Tamil Nadu State AIDS Control Society, the formation of 2 District AIDS Prevention and Control Units at Ariyalur and Tiruppur has approved on bifurcation of districts, since the functioning of 2 District AIDS Prevention and Control Units was necessary for providing services to People Living Human Immunodeficiencies Virus (PLHIVs). Though the EC has approved the functioning of 2 District AIDS Prevention and Control Units at Ariyalur and Tiruppur, National AIDS Control Organisation (NACO) has not yet been considered the establishment of 2 additional District AIDS Prevention and Control Units on bifurcation of districts. Hence, the funds for functioning of 2 District AIDS Prevention and Control Units are being reimbursed by the Government.

4. The Project Director, Tamil Nadu State AIDS Control Society has further stated that the functioning of above 2 District AIDS Prevention and Control Units at Ariyalur and Tiruppur is very necessary for providing services to People Living Human Immunodeficiencies Virus (PLHIVs) and has therefore requested to release

the funds allocated towards meeting out the expenditure for functioning of the 2 District AIDS Prevention and Control Units in Ariyalur & Tiruppur.

5. The Government after careful examination of the proposal of the Project Director, Tamil Nadu State AIDS Control Society accept the same and accordingly release a sum of Rs.59,28,000/- (Rupees Fifty nine lakh and twenty eight thousand only) towards meeting out the expenditure for functioning of the 2 District AIDS Prevention and Control Units in Ariyalur & Tiruppur.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:

2210 – Medical and Public Health 01 Urban Health Services – Allopathy  
200 - other Health Schemes – State's Expenditure – JB – The District AIDS Prevention and Control Units at Ariyalur and Tiruppur.
