ORDER:-

In the letter first read above, the Tamil Nadu Public Service Commission has recommended to prescribe "Master's degree in Statistics (or) Bio-Statistics" as the educational qualification for the post of Statistical Officer / Assistant Director (State Bureau of Health Intelligence) in Tamil Nadu Public Health Service for direct recruitment.

- 2. In the letter third read above, the Director of Public Health and Preventive Medicine has requested, the Government to issue necessary amendment to the Special Rules for the Tamil Nadu Public Health Service based on the recommendations of the Tamil Nadu Public Service Commission.
- 3. The Government have examined the proposal of the Director of Public Health and Preventive Medicine and decided to accept the recommendation of the Tamil Nadu Public Service Commission.
- 4. In their letter fifth read above, the Tamil Nadu Public Service Commission has given its concurrence for amending the Special Rules for Tamil Nadu Public Health Service.

5. Accordingly, the following Notification appended to this Government Order and it shall be published in the <u>Tamil Nadu Government Gazette</u>.

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Public Health Service (Section 24 in Volume II of the Tamil Nadu Services Manual, 1969).

AMENDMENT.

In the said Rules, in rule 4, in sub-rule (1), in the TABLE, under the heading Class-l in column (1),

for the entries "(i) M.Sc., degree in Statistics or Bio-Statistics or Demography" in Column (3) against the entry "(b) Direct recruitment" in Column (2) and against the entries "4 Statistical Officer" and "4A Assistant Director (State Bureau of Health Intelligence)" in Column (1) thereof the following entries shall be substituted namely:-

"(1) M.Sc. degree in Statistics or Bio-Statistics".
