ORDER

In the Government Order first read above, orders have been issued constituting "Medical Services Recruitment Board"(MRB).

2. In the Government Order second read above, orders have been issued directing the Medical Services Recruitment Board to recruit 2159 temporary posts of Medical Officers (911 General (MBBS), 1163 Speciality and 85 Dental) by conducting common Competitive Examination (objective type) separately for Medical and Dental candidates and by following the communal rotation, for the year 2012-2013, pending issue of amendment to the Tamil Nadu Public Service Commission Regulations, 1954 to exclude the post of Assistant Surgeon and Assistant Surgeon(Dental) from the recruitment purview of the Tamil Nadu Public Service Commission.

3. In the Government Order third read above, based on the concurrence of the Tamil Nadu Public Service Commission, for excluding the post of Assistant Surgeon and Assistant Surgeon (Dental) in the Tamil Nadu Medical Service from the recruitment purview of the Tamil Nadu Public Service Commission, orders have been issued permitting the Medical Services Recruitment Board to recruit Assistant Surgeon (Class I, Category 2 of the Special Rules for the Tamil Nadu Medical Service) and Assistant Surgeon (Dental) (Class IX, Category 4 of the Special Rules for the Tamil Nadu Medical Service) for regular appointment in the Tamil Nadu Medical Service.

4. As notified, all the 911 posts of Assistant Surgeon (General) were filled up. In respect of the post of Assistant Surgeon in various Specialty Departments out of 1163 posts notified, only 197 posts were filled up due to paucity of eligible applicants/ candidates. During the review meeting conducted by the Hon'ble Minister (Health) on 6th February 2014 on the staff position and vacancies in Government Medical Institutions, it was decided to explore the possibility of 'walk-in' selection process.

5. The Government has therefore, decided to fill up the vacancies in the post of Assistant Surgeon in various Specialty Departments in the Tamil Nadu Medical Service by 'walk-in' selection process. Accordingly, the Government issues the following orders:-

- i) the Medical Services Recruitment Board is directed to conduct 'walk-in' selection process in every quarter of the year, after due notification in the newspaper, for selecting eligible candidates to fill up the post of Assistant Surgeon in various Specialty Departments in the Tamil Nadu Medical Service duly following the communal rotation and rule of reservation as per orders in force by adopting the following methodology for selection of candidates:-

During the selection, if more than one eligible applicant is available in the same Community, in a Specialty, Post Graduate Degree holders should be preferred over Diploma holders and the selection should be based on the marks (in actual %) obtained by the applicant in the Post Graduate Degree/Diploma.

- ii) the Director of Public Health and Preventive Medicine is directed to appoint the candidates selected through the 'walk-in' selection process temporarily in the Tamil Nadu Medical Service, in relaxation of rule 10(a)(i) of the General Rules for the Tamil Nadu State and Subordinate Services and to regularize their services by conducting a Special Qualifying Examination by the Medical Services Recruitment Board after issue of amendment to the Tamil Nadu Public Service Commission Regulations 1954 to exclude the post of Assistant Surgeon and Assistant Surgeon (Dental) from the recruitment purview of the Tamil Nadu Public Service Commission.
- iii) the Medical Services Recruitment Board is directed to recruit candidate for vacancies in the post of Assistant Surgeon in various Speciality Departments in the Tamil Nadu Medical Service hereafter, as per the process detailed above.
- iv) the Director of Public Health and Preventive Medicine, the appointing authority for the post of Assistant Surgeon is directed to compile the vacancies in various speciality departments in the medical institution under the various Directorates and furnish to Medical Services Recruitment Board, every quarters, so as to enable the Medical Services Recruitment Board to select the candidates through the above mentioned process. While furnishing the number of vacancies, the Director of Public Health and Preventive Medicine is directed to ensure that proper orders are obtained for revival of lapsed posts, if any based on actual requirement.

6. This orders issues with the concurrence of Personnel and Administrative Department and Finance Department vide their U.O.No.8162/C1/2014, dated:03.03.2014 and U.O.No.14076/H-II/2014, Dated:22.04.2014 respectively.
