ORDER:

The Hon'ble Minister Health and Family Welfare on 14.05.2018, in the floor of the Assembly, among others, announced that Trauma Care Centres will be established under Tamil Nadu Accident and Emergency Care Initiative (TAEI) Scheme in Government Medical College Hospital Chengalpattu, Government Medical College Hospital Coimbatore and Head Quarters Hospitals in Kallakurichi and Kumbakonam at a cost of Rs. 28.30 Crores.

2) The Government of India have conveyed the sanction of the President for release of first installment (60%) towards construction / Civil Works and Procurement of Equipment under the scheme 'Capacity building for Trauma Care facilities in Government Hospitals on National Highways' as detailed at column 7 below and as agreed in the MoU already executed.

3) The Director of Medical Education has now requested for sanction of 40% of Government of Tamil Nadu State's Share i.e. Rs.11.32 Crores (Rupees Eleven Crores and thirty two lakhs only) to the above 4 Medical Institutions, for non recurring component in the Budget Estimate for the year 2018-19.

4) The Government after careful examination of the proposal of the Director of Medical Education accord administrative and financial sanction for a sum of Rs.28.30 Crore (Central Share: Rs.16.98 Crore + State Share: Rs.11.32 Crore) being Rs. 5.50 Crore towards infrastructure and Rs.22.80 Crore towards equipments for Trauma Care Facilities at Government Medical College Hospitals in Chengalpattu and Coimbatore and Government Head Quarters Hospitals in Kallakurichi and Kumbakonam as detailed in para 2 above under the programme "Capacity building for Trauma Care Facilities in Government Hospitals on National Highways".

5) The expenditure sanctioned in para 4 shall be debited in the following heads of account [Demand No. 1903 Director of Medical Education]

7) The construction work shall be undertaken by the Public Works Department of the State Government. Necessary fund provisions have been made in Demand No.19 Health and Family Welfare Department under the Head of Account 4210 - 01 – 200 - UA - 16 Major Works for the purpose of construction. All the existing procedures and formalities shall be followed by both the Director of Medical Education and Chief Engineer (Buildings), Public Works Department.

8) The Director of Medical Education is also directed to send necessary estimation of the Public Works Department in the matter.
