From the Director of Medical Education letter No.3196/P&D1/1/19, dated 16.02.2019.

ORDER:

In his letter read above, the Director of Medical Education has stated that the Government ESI Medical College Hospital, Coimbatore was handed over to Tamil Nadu Government by ESI Corporation on 29.11.2016. The ESI Hospital, Coimbatore only has the high tension connection (SC.No.192) whereby Government Medical College does not have a separate High Tension connection. Hence, the separate new High Tension (HT) (500 KVA) connection, for the above college is very essential for the following reasons:-

- a) Now the electricity charges for both Government Medical College and ESI Hospital is paid only by ESI Hospital, which leads to payment of huge amount as caution deposit for Electricity Board.
- b) As lab tests are carried out in the Government Medical College and the departments like Bio Chemistry, Pathology and Microbiology requires a High Tension (HT) connection.
- c) In the Medical College, there are many expensive laboratory equipments in the department of Bio Chemistry, Pathology and Microbiology which are to be kept only in the air conditioned room and hence in order to operate the Chiller Unit, a High Tension (500 KVA) connection is needed separately for the college.
- d) There are separate Head of account for the Medical College and ESI Hospital till date and the electricity charges for the Hospital College and ESI Hospital are paid together under the ESI Hospital head of account for more than two years.
- 2. The Director of Medical Education has therefore requested the Government to accord necessary administrative and financial sanction for Rs.44.00 Lakhs for the year 2019 2020 for provision of separate HT service connection arrangements viz., HT VCB panel and HT Cable to Government ESI Medical College, Coimbatore.
- 3. After detailed examination, the Government have decided to accept the request of the Director of Medical Education. Accordingly the Government do and hereby accorded an administrative and financial sanction for a sum of

Rs.42.00 lakhs (Rupees Forty Two lakhs only) towards provision of separate High Tension (HT) service connection arrangements viz., HT VCB panel and HT cable to Government ESI Medical College, Coimbatore on reimburse basis.

- 4. The Director of Medical Education is also directed to reimburse this amount as and when received from ESI, Delhi.
- 5. The amount sanctioned at para 3 above shall be debited under the following Head of Account [Demand No: 39-02]
