

Establishment of Out Patient block, Ophthalmic Ward building and Mortuary Buildings at Government Head Quarters Hospital, Usilampatti - Administrative and Financial sanction -Accorded - Orders - Issued.

ORDER:

The Hon'ble Chief Minister during the Collector's Conference, 2013 had among others announced that Out Patient Block, Dialysis Ward and Ophthalmic Ward will be established at Government Hospital, Usilampatti in Madurai District.

- 2. Based on the above announcement, in the Government Order first read above, the Government have sanctioned a sum of Rs.275 lakhs to the Chief Engineer (Buildings), Public Works Department for execution of Civil Works viz., 48 bedded Post-Operative ward, 24 bedded Base Eye ward, Mortuary block with cold storage and Out-patient department at the District Head Quarters Hospital, Usilampatti, Madurai.
- 3. In the letter second read above, the Director of Medical and Rural Health Services has stated that, the Joint Director of Health Services, Madurai at Usilampatti has stated that the proposed site is little far away from the existing hospital campus and surrounded by residential buildings and schools. The local people had raised heavy objections for construction of hospital buildings adjacent to the residential area and various steps taken to convince the public were in Hence, it has been decided to construct the new building by accommodating all the facilities within the existing Government Hospital campus by dismanting the old buildings, since there is no space available within the campus and has furnished the revised rough cost estimate of the Chief Engineer (Buildings) for construction of Out Patient block, Ophthalmic Ward, Post-Operative Ward building and Mortuary Buildings at a cost of Rs.803.00 lakhs for the year 2018-19 and Rs.888.00 lakhs for the year 2019-20.

- 4. The Director of Medical and Rural Health Services has justified that, the Government Hospital, Usilampatti, is functioning as Headquarters Hospital for Madurai District consequent on starting of Medical College Hospital at Madurai with 135 beds and providing quality medical care to the patients in and around the area, with an average of 1417 Out Patients, 159 In patients per day and 251 major and 541 minor surgeries, 258 deliveries per month are being done. Other medical facilities such as X-Rays, USG-Scans, ECG, Lab-Tests and Post Mortem are also provided in the said hospital. Nearly 80% of the out patients are attending the hospital with the symptoms of huge number of various kinds of medical diseases inclusive of Fatigue, Frequent need to Urinate, especially @ night, Itchy Skin, Shortness of Breath, Blood in Urine, Protine in Urine and etc., which causes of Kidney diseases (viz) Diabetes, Hypertension, Malaria, Kidney infection, Jaundice, Yellow fever, Rat fever and etc. The injection for male and female are administered with the help of single screen. Specialty out patients such as ENT, Ophthalmic, Ortho, OG, Non Communicable Disease are also being managed under one roof. The Sterile operation theatre for Ophthalmic Procedures is also very much essential. welfare of the public, the Director of Medical and Rural Health Services has stated that construction of Out Patient block, Ophthalmic Ward, Post-Operative Ward building and Mortuary Buildings at Government Headquarters Hospital, Usilampatti is absolutely necessary.
- 5. The Director of Medical and Rural Health Services has therefore requested necessary orders in this regard.
- 6. The Government, after careful consideration, have decided to accept the proposal of the Director of Medical and Rural Health Services and in supersession of the orders issued in Government Order first read above, the Government, accord Administrative and Financial sanction an amount of Rs.801.15 lakhs (Rupees Eight crore one lakhs and fifteen thousand only) for the Establishment of Out Patient block, Ophthalmic Ward, Post-Operative Ward building and Mortuary Buildings at Government Headquarters Hospital, Usilampatti.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following Head of Account:- (Demand No.39-02)

"4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 – Hospitals and Dispensaries (including Pharmacy) –State's Expenditure – JA Buildings – 416 Major Works – 01 Major Works"

8. The expenditure sanctioned in para 6 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical and Rural Health Services is requested to send necessary

explanatory notes to include the above expenditure in the supplementary Estimates for the year 2019-2020 to Finance (BG-I) Department at the appropriate time without fail.
