- ii) Clinical training may be given without any hindrance to the normal functioning of the Government Hospital, Sankarankoil, Tirunelveli District and Government Hospital, Rajapalayam, Virudhunagar District and without any financial implications to the Government.
- iii) The institution should pay the prescribed fees for the students who are deputed for training.

- iv) The Hospital should maintain 1:3 student: patient ratio every day of clinical training based on rotation.
- 2. The Director of Medical and Rural Health Services, Chennai is directed to take necessary action accordingly.
