## ORDER:

The Chief Minister's Comprehensive Health Insurance Scheme is under implementation under the Tamil Nadu Health Systems Project as per the Government Order first read above. In the G.O. second read above, the following posts were sanctioned for the strengthening the monitoring system of the Tamil Nadu Health Systems Project at Head Quarters till the scheme is in force:-

The Project Director, Tamil Nadu Health Systems Project, Chennai was authorized to fill up the above posts by deputation wherever possible and if not, by outsourcing / contract.

- 2. The Project Director, Tamil Nadu Health Systems Project in his letter fourth read above has now stated that the posts of 7 Medical Officers have been filled up on deputation / transfer basis in the time scale of pay and the posts of Computer Operator and Office Assistant, action is being taken separately to fill up the posts on deputation / transfer basis or on contract basis. He has also stated that for the posts of IEC Expert and MIS Expert, have been filled up by contract basis by him as there was no regular staff on deputation/transfer basis available for appointment. The IEC Expert and MIS Expert have joined duty on 13.9.2013 and 18.10.2013 respectively and their monthly contract pay has been fixed at Rs. 25000/- and Rs. 18000/- p.m. respectively.
- 3. The Project Director has further stated that provision has not been made in G.O. (Ms) No.59, Health and Family Welfare (EAPII/2) Department, dated:28.03.2013 regarding the subhead of account '33 PP SS 04 contract pay' so as to enable the Project Director to claim the pay to the contract staff. Hence in Government Letter No.5831/EAPI/1/2014-1, Health and Family Welfare Department, dated: 20.02.2014 necessary amendment was issued to the said G.O regarding claiming of contract pay.
- 4. The Project Director has stated that the Government have sanctioned a sum of Rs.3,00,000/- under the head of account 2210-80-800-JJ-33-04 contract pay in the FMA 2013-14 so as to enable the Project Director to claim the contract pay. Accordingly, the pay of the IEC expert and MIS Expert were sanctioned and claimed upto the month of February 2014.
- 5. The Project Director, Tamil Nadu Health Systems Project has requested to allot a sum of Rs.5,25,000/- under the sub-detailed head of account '33 PP SS 04 contract pay' to the above said posts pending provision of funds in the Revised Estimated 2014-15. The Project Director, has also requested that pending provision of funds in Revised Estimate 2014-15, he may be permitted to claim the contract pay and the Pay and Accounts Officer (South), Chennai-35 may be permitted to admit the contract pay bills as and when presented.
- 6. The Government after careful consideration of the request of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same. Accordingly the Government sanction a sum of Rs.5,25,000/- (Rupees five lakhs and

twenty five thousand only) towards contract payment at Rs.25,000/- per month to IEC Expert and Rs.18,000/- per month to MIS Expert employed in Tamil Nadu Health Systems Project head sanction.

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-

2210 Medical and Public Health – 80 General 800 Other Expenditure – Scheme in the Twelth Five Year Plan II State Plan JJ Chief Ministers Comprehensive Health Insurance Scheme 33 Payment for Provisional and Special Services 04 Contract Payment (2210 80 800 JJ 3340).

- 8. Necessary additional funds will be provided in Revised Estimate / Final Modification Appropriation 2014-15 to meet the expenditure sanctioned in para 6 above Pending provision of such funds in Revised Estimate / Final Modification Appropriation 2014-15, the Project Director, Tamil Nadu Health Systems Project is authorised to draw and incur the expenditure and he is requested to include the expenditure sanctioned above, while sending the Budget proposal for Revised Estimate / Final Modification Appropriation 2014-15 to Government in Finance Department without fail.
- 9. This order issues with the concurrence of Finance Department vide its U.O. No. 45524/H-II/2014, Dated: 09.09.2014 and Additional Sanction Ledger No.1042 (One Thousand and Forty Two).
