ORDER:

In the Government order first read above, orders have been issued to strengthening of Maternity Child Health Wing in Government Ranees Hospital, Pudukottai at a cost of Rs.2000 lakh with National Health Mission funds and permitted to execute the civil works for strengthening the Maternity Child Health Wing in Government Ranees Hospital, Pudukkottai at a total cost of Rs.1800.00 Lakh through Public Works Department. Sanction was also accorded for an amount of Rs.100 lakh out of the total sanction for civil work of Rs.1800 lakh for execution of civil works through Public Works department.

2. In the G.O second read above, a sum of Rs.1000.00 lakh was sanctioned for the civil works for strengthening the Maternity Child Health wing in Government Ranees Hospital, Pudukottai through Public Works Department.

3. In the Supplementary Record of Proceedings 2016-17, balance sum of Rs.600.00 lakhs for civil works of Maternity Child Health wing in Government Ranees Hospital Pudukottai has been approved. The above amount had been remitted into Government account vide Challan No.183 dated 20.02.2018 of SBI Treasury Branch, Thousand Light, Chennai -6.

4. The Mission Director, State Health Society has requested necessary orders in this regard.

5. The Government after careful examination have decided to accept the proposal of the Mission Director, State Health Society and issue following orders:-

- i. Permission is accorded to incur a sum of Rs.600.00 lakh (Rupees Six crore only) for the civil works through Public Works Department, for strengthening Maternity Child Health wing in Government Ranees Hospital , Pudukottai, Pudukottai District
- ii. The Engineer-in-Chief and Chief Engineer (Buildings) Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds under the head of account "4211-00 Capital out lay on Family Welfare".

6. The expenditure sanctioned in para 5 (i) above shall be debited in the following head of account

"4211-00 capital outlay on family welfare – 103 Maternity and Child Health – State's Expenditure – AA Civil Works under National Health Mission Scheme – 16 Major Works".
