#### ORDER:

The Government of India in its letter first read above has stated that the Grants in aid to State AIDS Control Societies for implementation of the National AIDS Control Programme, a Centrally Sponsored Schemes under the Major Head 2210 – Medical and Public Health 06 101- Prevention and Control of Disease (Minor head) 33 National AIDS Control Programme (Sub head) have been released under 3601/3602 to the State concerned with the head of accounts mentioned therein and the concerned State Government Treasuries may be contacted for further information with regard to transfer of the funds released by the Department of AIDS Control to the State AIDS Control Societies. The Department of AIDS Control, New Delhi in the letter third read above has sanctioned the following amount to Tamil Nadu State AIDS Control Society and requested the Government to release the following amounts to Tamil Nadu State AIDS Control Society:-

- i. Rs.7,56,00,000/- (Rupees Seven Crore Fifty Six Lakhs Only) under TI- World Bank fund during 2014-15.
- ii. Rs.13,55,00,000/- (Rupees Thirteen Crore and Fifty Five Lakhs Only) under DBS fund during 2014-15.

2. In the letter third read above, the Department of AIDS Control, New Delhi has also sanctioned the following amounts:-

- i. Rs. 9,92,00,000/- (Rupees Nine Crore and Ninety Two Lakhs Only)- under Global Fund during 2014-15 (DAC letter No.M-18017/05/2014-15-NACO (F) (RD-II) dated 02.06.2014).

- ii. Rs. 2,74,00,000/- (Rupees Two Crore and Seventy Four lakh Only) – under Global fund during 2014-15 (DAC letter No. 18017/05/2014-15-NACO (F) (RD-VII) dated 02.06.2014).
- iii. Rs.5,39,87,000/- (Rupees Five Crore Thirty Nine Lakh Eighty Seven Thousand Only), - under DBS-CST during 2014-15. (DAC letter No.M.18017/4/2013-NACO-(F)-CST dated:16.06.2014).

3. In the letter second and fourth read above, the Project Director, Tamil Nadu State AIDS Control Society has requested the Government to release the total amount of Rs.39,16,87,000/- to Tamil Nadu State AIDS Control Society. which has been released by the Department of AIDS Control, New Delhi for the implementation of various Programmes / Schemes for 2014-15 and for the payment of Salaries to the Staff of Tamil Nadu State AIDS Control Society working in various programme centres of Tamil Nadu State AIDS Control Society.

4. Sanction is accorded for Rs.39,16,87,000/- crores from the amount released by Government of India to the Tamil Nadu State AIDS Control Society as detailed in para first and second above for the implementation of various Programmes / Schemes for 2014-15 by Tamil Nadu State AIDS Control Society and for the payment of Salaries to the Staff of Tamil Nadu State AIDS Control Society working in various programme centres of Tamil Nadu State AIDS Control Society across the State.

5. The expenditure sanctioned in para 4 above shall be debited to the following new head of account:-

2210 - Medical and public health 80 - General 800 – Other expenditure III. Centrally Sponsored SA – Grants to Tamil Nadu State AIDS Control Society 09 – Grants-in-Aid 03 – Grants for Specific Schemes (DPC: 2210–80-800-SA-0931)

6. Necessary funds are available in the first supplementary Estimates 2014-15.

7. The Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 4 above. The Director of Medical Education is the Estimating Reconciling and controlling Authority for the above head of account.
