## ORDER:

In Government order second read above, orders were issued to establish 12 new Primary Health Centres under National Health Mission and .financial sanction has been accorded for a sum of Rs.144.00 lakh being 20% of the total amount of Rs.720.00 lakh (12 X Rs.60.00 lakh) for execution of civil works through Public Works Department.

- 2. In the letter third read above the Mission Director, State Health Society has stated that in Record of Proceedings 2017-18, the Government of India has approved Rs.288.00 lakh being 40% of the total amount of Rs.720.00 lakh (12 X Rs.60.00 lakh) and in Supplementary Record of Proceedings 2017-18 the Government of India has approved Rs.144.00 lakh being 20% of the total amount of Rs.720.00 lakh for the above 12 Primary Health Centres.
- 3. The Mission Director has also stated that as per the Government order first read above, the above approved amount i.e. Rs.432.00 lakh (Rs.288.00 lakh + Rs. 144.00 lakh) has been remitted to Government account vide challan No.115, dated 06.11.2017 and Challan No.208, dated 27.02.2018.
- 4. The Mission Director, National Health Mission has therefore requested necessary Government orders in this regard.
- 5. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:
  - i. A sum of Rs.4,32,00,000/-(Rupees Four crore thirty two lakh only) being 60% of the total amount of Rs.720.00 lakh ( 12 X Rs.60.00 lakh) be

sanctioned under National Health Mission in addition to Rs.144.00 lakh sanctioned vide Government Order 2<sup>nd</sup> read above for executing the civil works through Public Works Department for the following 12 Primary Health Centres.
