In the Government Order first read above, one post of State Maternal and Child Health Officer with grade pay of 8700 in Pay Band-IV at Headquarters of the Director of Public Health and Preventive Medicine and 6 posts of Joint State Maternal and Child Health Officer with Grade Pay 7600/- PB-III under the control of the Director of Public Health and Preventive Medicine were created.

2. In the Government Order second read above, orders were issued filling up of the post of State Maternal and Child Health Officer on adhoc basis from among the holders of the post of Maternal and Child Health Officer.

3. In the letter third read above, the Director of Public Health and Preventive Medicine has requested to issue adhoc rules for the post of State Maternal and Child Health Officer so as to fill up the said post on regular basis.

4. The Government have examined the proposal of the Director of Public Health and Preventive Medicine and decided to accept the same and issue the adhoc rules for the post of State Maternal and Child Health Officer.

5. Accordingly, the appended notification shall be published in the Tamil Nadu Government Gazette.

**APPENDIX.**  
**NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on and from the 28<sup>th</sup> July 2014.

**RULES.**

The General and the Special Rules applicable to the holders of the permanent post of Class-1 of the Tamil Nadu Public Health Service shall apply to the holders of the temporary post of State Maternal and Child Health Officer, sanctioned from time to time in the Directorate of Public Health and Preventive Medicine, subject to the modifications specified in the following rules:

Provided that with effect on and from the 15<sup>th</sup> September 2016, the provisions contained in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in Class-I of the Tamil Nadu Public Health Service shall apply to the holder of the post.

2. **Constitution** - The post shall constitute a distinct class of the said service.

3. **Appointment** - Appointment to the post shall be made by promotion from among the holders of the post of Joint Maternal and Child Health Officer in the Tamil Nadu Public Health Service in the Directorate of Public Health and Preventive Medicine.

4. **Appointing Authority** - The appointing authority for the post shall be the Government.

5. **Qualification** - No person shall be eligible for appointment to the post unless he possesses the service qualification for a period of not less than one year in the post of Joint State Maternal and Child Health Officer.

6. **Preparation of annual list of approved candidates and crucial date** - For the purpose of preparation of annual list of approved candidates for appointment to the post, the crucial date on which the candidates should have acquired the prescribed qualifications shall be the 15th February of every year.


7. **Pay** - There shall be paid to the holder of the post, monthly pay calculated in the Pay Band-4 of Rs.37400 – 67000 + Grade Pay of Rs.8,700/- :

Provided that, monthly pay shall be calculated in Level 28 – Rs.123100 – 215900 under the Tamil Nadu Revised Pay Rules, 2017, notionally with effect from the 1<sup>st</sup> January, 2016, and with monetary benefit from 1<sup>st</sup> October, 2017.

8. **Saving** - Nothing contained in these rules shall adversely affect any person holding the post as on the date of publication of these rules in the Tamil Nadu Government Gazette.
