In the circumstances reported by the Director of Medical and Rural Health Services in the letter third read above, permission is accorded to the Chairman, AAB College of Nursing, Thellur, Thiruvannamalai District to have tie-up arrangements with the Government Hospital, Cheyyar, Thiruvannamalai District to avail clinical training for all their Diploma in General Nursing and Midwifery (DGNM) Course students for a period of three years from the academic year 2015-2016, subject to the following conditions:-

- i) Students should be deputed in small batches;
- ii) Clinical training may be given without any hindrance to the normal functioning of the Government Hospital, Cheyyar, Thiruvannamalai District and without any financial implications to the Government.

- iii) The Hospital should maintain 1:3 students: patients ratio every day of clinical training based on rotation.
- iv) The Director of Medical Education, Chennai may also be requested to ensure that the above college has constructed its own 100 bedded hospital within a period of 3 years as stated in the affidavit submitted by the Chairman. If not, the college authorities may be informed any other request for enhancement of seats, renewal of continuation of tie up arrangements will not be entertained in future unless the above condition is fulfilled.

2. The Director of Medical and Rural Health Services, Chennai is directed to take necessary action accordingly.
