

National Health Mission - State Health Society - Tamil Nadu - Permission to National Health Mission for Establishment of Special New Born Care Units at Government Hospital, Kodaikanal and sanction of posts of contractual and regular Staff Nurses support staff for setting up Special New Born Care Units at Government Hospital, Kodaikanal – Accorded - Orders - Issued.

ORDER:

In the letter read above, the Mission Director, National Health Mission has stated that the Special Newborn Care Units have been established in the State, under National Rural Health Mission, in a phased manner. So far, 73 Special New Born Care Units have been established in the State under the National Health Mission for reduce the neonatal deaths. Out of which 24 Special New born Care Units are in Medical College Hospitals/ Facilities functioning under Directorate of Medical Education, 24 Special New Born Care Units are in District Head Quarters Hospitals and 25 Special New Born Care Units are in Sub District Hospitals under Directorate of Medical and Rural Health Services.

2. The Mission Director, National Health Mission has stated that, a proposal to establish 8 bedded Special New Born Care Units at Kodaikanal Government Hospital have been included in the Programme Implementation Plan 2019-20 and approved by the National Programme Co-ordination Committee (NPCC) in the Record of Proceedings 2019-20. The Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai is also one of the members in the 37th Executive Committee Meeting held on 11.2.2019 and the same has been approved vide Agenda No. 12/37/2019 in the 37th Executive Committee Meeting.

3. The Mission Director, National Health Mission has also stated that, the Government Hospital, Kodaikanal caters to the hilly area population and hard to reach area, it is essential to be upgraded / strengthened as Special New born Care Units so as to reduce the IMR from 17 to 9 per 1000 live births in 2030 as per the India New born Action Plan. The amount approved in Record of Proceedings 2019-20 is as detailed below:-

The Mission Director, National Health Mission has further stated that the funds approved in Record of Proceedings 2019-20 shall be released to State Health Society Tamil Nadu in the quarter of Financial Year 2019-20 and subsequently remitted into Government Account. In respect to Support staff, lumpsum cost is approved and hence 3 female Multi Purpose Hospital Worker and 3 male Multi Purpose Hospital Worker per Special New born Care Unit as given for earlier Special New born Care Units may be approved.
- 5. The Mission Director, National Health Mission has requested necessary orders in this regard.
- 6. The Government after careful examination have decided to accept the proposal of the Mission Director, National Health Mission and issue the following orders:
 - i. The Mission Director, National Health Mission is permitted to establish Special New Born Care Units at Government Hospital, Kodaikanal.
 - ii. Sanction is accorded for the ten posts of Staff Nurses for the above Special New Born Care Units at Government Hospital, Kodaikanal in ratio of 2:1 in each unit as per G.O(Ms)No.400, Health and Family Welfare (AA1) Department, dated: 16.12.2014 as follows:

- iii. The Mission Director is permitted to place the Support staff (3 Male Multi Purpose Hospital Worker and 3 female Multi Purpose Hospital Worker) in the above said Special New Born Care Units on contract basis through outsourcing by the concerned Joint Director Health Service.
- iv. The Director of Medical and Rural Health Services is permitted to fill up the post of Staff Nurse created as per the existing procedure.
- v. Pay and allowance to the Staff Nurse in time scale of pay shall be drawn through the concern Drawing and Disbursing Officer by Treasury mode. The salary for the Staff Nurses on Contract in posts will be paid by National Health Mission / State Health Society, Tamil Nadu from the funds approved under National Rural Health Mission through Director of Medical and Rural Health Services. The Mission Director, National Health Mission is permitted to release salary cost for Staff Nurse on contract basis to Director of Medical and Rural Health Services.
- vi. The Mission Director, National Health Mission is permitted to remit the salary cost of Staff Nurses as approved by Government of India from time to time to the State Government account, as and when received, as per the existing procedure.
- vii. The Mission Director, National Health Mission is permitted to rationalize the Staff nurse as per need based on case load among the Government institutions.
- 7. The amount sanctioned in Para 6 (ii) shall be debited under the following Head of Account

8. The Mission Director, State Health Society shall remit the Human Resource cost approved under National Rural Health Mission in respect of post indicated in Para 6 (ii) in the following receipt Head of Account.

9. The expenditure sanctioned in Para -6(ii) above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is directed to apply for sanction of advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The

Director of Medical and Rural Health Services is requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2019-2020 to Finance (BG.I/Health.I) Department without fail.
